ORDINANCE NO. 2024-1- HETTINGER COUNTY, NORTH DAKOTA ORDINANCE PROHIBITING USE OF ENGINE BRAKES

Article I.

The following traffic offense is hereby ordained by the Hettinger County Commission: A. Engine Brakes — Prohibited Use

This ordinance applies to the use or operation of an auxiliary or compression engine brake (also known as "Jake Brake") which produces noise in addition to the normal operating engine noise.

It shall be a traffic offense, except in emergency situations, for any driver of a truck or truck -tractor to activate or use the unit's engine brake upon State Highway 22 and State Hwy 21 in Hettinger County, North Dakota starting from 1 mile north of New England City limits on State Highway 22, 1 mile south of New England city limits on State Highway 22 and 1 mile west of New England city limits on State Highway 21 when a traffic sign prohibiting such use and signifying that a vehicle noise ordinance is enforced. The County may affix the amount of the penalty to the traffic sign as allowed under 11-10-31 NDCC.

The term "emergency situation," for the purposes of this ordinance shall mean one in which there is imminent danger of collision with property, person or animal.

The penalty sign must be uniform in size and text in relation to the traffic sign to which it is affixed and in compliance with the manual on uniform traffic control devices.

B Penalty

1. Any person, or persons, violating or failing to comply with any provision of this Ordinance commits a traffic offense and is to be fined, upon conviction, a non-criminal administrative penalty of Five Hundred Dollars (\$500.00) for each offense.

Article II.

1. It is hereby declared to be the intention of the Hettinger County Commission that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections, of this ordinance, since the same would have been enacted by the County Commission without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.

Article III.

1. This ordinance will take effect immediately from and after its passage and publication for three consecutive weeks of this ordinance in the official county newspaper.


2. If older children are trick-or-treating alone, plan a safe route and means of communication.
