her caramels. "I said, 'Yeah, right," she says, scoffing at the idea despite the fact that everyone was asking for the treats.

But she took ahold of the idea and attended craft fairs in Medora and Dickinson.

"They went over a lot better than I assumed that they would," she says. "I was shocked."

Over the last couple years, she has developed packaging and labels as the Christmas tradition turned into a larger endeavor.

Businesses have purchased her caramels for employee or customer gifts, and families send them to distant relatives, as her palate-pleasing caramels became more popular.

Last Christmas, she made at least 20,000 caramels.

"I have to make them year-round to make the quantity I need at Christmastime, and then I still find myself scrambling to get more done," she says, so she stockpiles caramels in the freezer until they are needed.

"If I don't freeze them, I would not be able to make them at the quantity that I do," she says.

Her caramels include four staples: Regular, Krispie with chocolate and Rice Krispies, Turtle with pecans and chocolate and Sea Salt.

"I had an elderly lady the last couple of years stop at the craft fair and ask if I had made black licorice. And I said, 'No, I'm not really a big fan of it, so I'm not sure I would do it," she says. "Last year, she came to the craft fair and gave me her recipe and said, 'If you make them I will buy them."

So, black licorice was added to the line of flavors, along with a coconut caramel suggested by her husband.

Among the six flavors she has created, sea salt is her personal favorite, she says.

Developing a new flavor is a trial-anderror process, she says.

"With the pans that I used, I had to make sure that I multiplied the recipe just right to where it fills the pan completely. That's been challenging, and then finding the right thermometer that gives me the exact temperature," she says.

Caramel is temperamental, she points out.

"I got a new pot the other day and I had to throw two batches, because the temperature wasn't right and it was just one big Jolly Rancher the next day," she says.

"Over the years, I have found what product works and what product doesn't. Like Karo Syrup. It's gotta be Karo Syrup, because if it's an off brand, it does not work," she says.

After the caramel cooks and cools, she cuts it into squares and wraps each piece in colorful foil by hand.

Even though wrapping each individual caramel is labor-intensive, that is her favorite part of the process, she says.

"It's kind of therapeutic," she says.

can be added to a box. The only caramels not gluten-free are the Krispie flavor.

As her Christmas tradition grew into other people's homes, she enjoys spreading the joy of Christmas with her caramels.

"Anybody that I've given them to, they're like, 'Oh, I should send them to this person, I should send them to this person. They would love these," she says with a smile.
