Immediately following the organizational meeting, the District's Board of Directors will hold a public meeting with the following agenda.

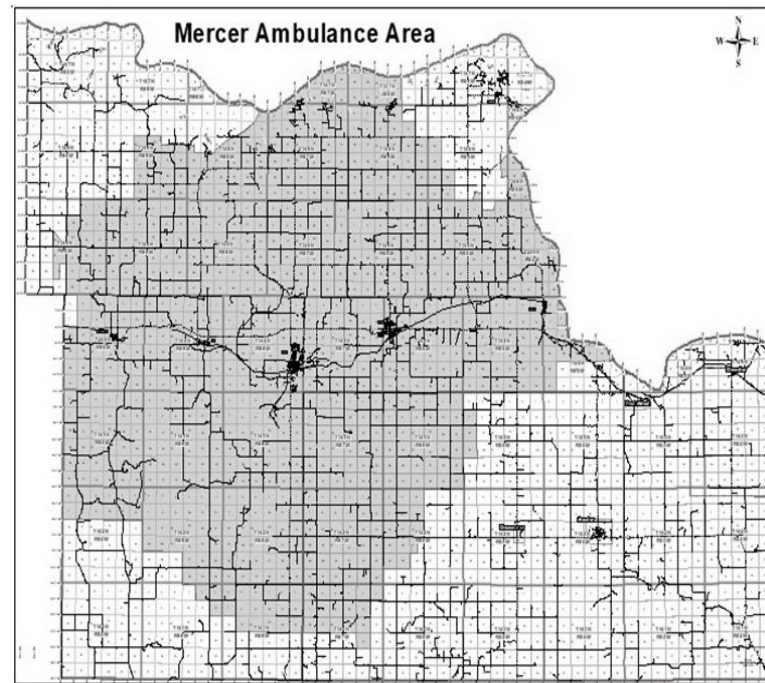
