WARC's food pantry.

"We purchased a two-wheeled dolly, a safety ladder and all new pellet shelving, which is deeper and higher, which allows us to store more groceries," Olheiser said. "The amount helped us extremely. It really helped improve our food pantry."

WARC, which purchases food locally and from Great Plains Food Bank, is a nonprofit organization dedicated to providing support and services to victims of domestic violence and sexual assault in rural North Dakota.

The Beulah-based center works to educate the public about all forms of domestic and sexual violence, available services and violence prevention with the ultimate goal of eliminating violence in society.

With its grant funding, the Ambulance Services, which is based in

Beulah and Hazen, purchased 16 new, reflective, three-season jackets for its many volunteers.

"We just didn't have enough coats for them all, so this helps add to our stock," Sailer said.

The department has roughly 20 to 25 volunteers between the two communities, according to Sailer.

"To Farm Credit Services, thank you for this opportunity," Sailer said.

The Rural Community grant funding was established as a partnership between Farm Credit Services of Mandan and AgCountry Farm Credit Services out of Minot and AgriBank Farm Credit Bank, St. Paul, Minn.-based funding bank, to help communities impacted by mineral development.

Funds are generated from mineral interest income out of western North Dakota, according to Farm Services.
