City Auditor Presnell was present with his report. The Rate Study is completed and will hear back at the end of April with results. Presnell attended the North Dakota League of Cities Spring Workshop in Minot and has started Auditors Training through the League of Cities. The Auditors' office is working on yearly records disposal. Richter made a motion to accept the report as given. McKnight seconded the motion. All in favor. Motion carried.

NEW BUSINESS:
McKnight made a motion to approve a gaming raffle for the NR-S Youth Archery, and bingo for the First Lutheran Church. Richter seconded the motion. All in favor. Motion carried.

Richter made a motion to approve a building permit for Randy Gudmunson. Belquist seconded the motion. All in favor. Motion carried.

An interested individual is looking to purchase a city lot for sale and requested pricing. The Commission decided on a price of \$5 a running foot, plus purchaser must be made away the special assessments on the property and that it will be their responsibility to

pay, and no farm hydrant will be allowed.

Richter made a motion to renew CD 1027054559 through Bank Forward into a 12-month CDAR's at a rate of 4.7% at Bank Forward. Belquist seconded the motion. All were in favor. Motion carried.

The Commission reviewed two complaints received. The first complaint was regarding the rocks from the chip seal being all over the boulevard. The Commission decided that no action be taken to clean up the rocks in the boulevard, but will instruct Public Works to get as much rock off the streets as possible. The second complaint was regarding the decision to move garbage totes twice a year. The Commission decided to offer this certain individual be placed on the list to have garbage picked up in the streets year-round.

McKnight made a motion to appoint Gerri McKay and Karen Anderson to the Tree Board for one-year terms. Richter seconded the motion. All in favor. Motion carried.

Richter made a motion to declare Arbor Day. McKnight seconded the motion. All in favor. Motion carried.

Richter presented the topic of city hall renovations. The roof leaks and the HVAC system is not up to correct standards. Richter and Presnell will get quotes and present them at the next regular meeting.

The New Rockford American Legion had a written proposal for a beer license. The Commission will review the matter if an application is turned in.

With no further business, the meeting was adjourned at 9:41 a.m.
