**The Week Ahead**

There could be light flurries as systems pass through, along with breezy periods. These periods of light snow are hard to forecast this far in advance, as each system will cover a small area with light accumulations.

More small systems dropping light snow seem likely through the first part of December. Any larger pattern changes should hold off until mid month.
