## Your Health: April is Prevent Child Abuse Month

April is Prevent Child Abuse Month, a time to celebrate children, focus on giving them all the childhood they deserve and highlight the importance of working together as a community to promote the wellbeing of families. So, while it is great to have a designated time to direct our attention to a topic, Prevent Child Abuse is really a year around effort. Abuse can be physical, emotional, or sexual. Today, I'd like to talk a bit more about steps we can take to prevent child sexual abuse. This can be a difficult subject however, abusers thrive on secrecy, shame and a child's lack of information. We can combat that by bringing it out into the open. As adults, it is ultimately

our responsibility to protect our children, but we can teach them skills to help them protect themselves. Here are some tips:

Take an active role in your kids'

lives. Learn about their activities and

people with whom they are involved. Stay alert for possible problems. Watch for "grooming" behaviors in adults who spend time with your child. Warning signs may include frequently finding ways to be alone with your child, ignoring your child's need

for privacy (e.g., in the bathroom), or

giving gifts or money for no particular

Ensure that organizations, groups, and teams that your children are involved with minimize one-on-one time between children and adults. Ask how staff and volunteers are screened and supervised.

Make sure your children know that they can talk to you about anything that bothers or confuses them.

Empower children to make decisions about their bodies by allowing them age-appropriate privacy and encouraging them to say "no" when they do not want to touch or be touched by others. For example, if you or your child isn't comfortable giving hugs to other family members, it is okay to not force hugs. You can encourage high-fives or fist bumps. The kid can also wave hello or goodbye.

Teach children to take care of their own bodies (e.g., bathing or using the bathroom) so they do not have to rely on adults or older children for help.

Educate children about the difference between good secrets, such as birthday surprises and bad secrets. Bad secrets make the child feel unsafe or uncomfortable.

Monitor children's use of technology, including cell phones, social networking sites, and messaging. Review contact lists regularly and ask about any people you don't recognize.

Trust your instincts! If you feel uneasy about leaving your child with someone, don't do it.
