The following information abbut Cody Hertz was submitted by family...

Cody joined the National Guard in 1993 while he was still in high school. He has been in the guard for over 30 years. He is still active duty but hopes to retire in a couple years. When Cody's company was deployed in 2003 it consisted of at least 14 men from **Grant County including** his father, Keith Hertz and his brother Robbie. Their company was with the 141st Engineer Combat Engineer. Their job in Iraq was to patrol the roadways, looking for IED's. They were known as the "Trailblazers" since they cleared the roadways of bombs for other soldiers to travel safely. It was a very dangerous job. Four soldiers in his

the tour, one belonging to his company while three others were in the other company within the Battalion. Several others were injured due to IED's exploding.

Most of the men returned home with emotional trauma. Through time, counseling and the love, care and support of family and friends, most have been able to return to relatively normal civilian life. However, there are still some that struggle with the memories of what they saw and had to do while in Iraq.

Cody is currently Chief Warrant Officer Five in the US Army National Guard in ND. We thank him and all the other men and women who have answered the call to serve our country. As citizens of this country, may we be worthy of the sacrifice they have made for us.
