Division B Volleyball All-Tournament Team and Senior Athlete of the Year announced

The 2025 Division B Volleyball postseason delivered another year filled with standout performances, dramatic tournament moments, and exceptional individual achievements.

This week, the Division B All-Tournament Team was announced, honoring 15 athletes whose play defined the championship stretch and elevated their programs on the state stage.

Alongside the team selections, the NDHSCA also named its Senior Athlete of the Year and Coach of the Year, both of which went to leaders from Medina-Pingree/Buchanan.

Langdon Area/Munich led the way among this year's honorees with three athletes recognized for their postseason efforts.

Freshman Hilary Haaven (9) emerged as one of the tournament's most promising young talents, showing poise beyond her age.

She was joined by sophomore standouts Kemi Morstad (10) and Taya Feist (10), two players who consistently delivered strong court coverage and attacking production for the Cardinals throughout their tournament run.

Medina-Pingree/Buchanan, one of the division's most balanced squads this season, placed a trio of experienced athletes on the All-Tournament Team.

Seniors Brynn Sorenson (12) and Violet Bohl (12), along with junior Destiny Opp (11), each played pivotal roles in MPB's success.

Sorenson, who anchored the group with commanding leadership and all-around excellence, was additionally named the 2025 NDHSCA Division B Senior Athlete of the Year, recognizing her as the state's top senior in Class B volley-

Central McLean junior Morgan Snyder (11) was also selected, representing the Cougars after a postseason marked by versatility, endurance, and reliable scoring.

Edgeley/Kulm/Montpelier added two honorees, senior Elli Lloyd (12) and junior Betsy Huber (11), both of whom helped EKM remain one of the tournament's most competitive and disciplined teams.

Flasher's Chaskee Schmidt (12) earned a spot following her standout senior postseason, providing the Bulldogs with consistency and high-

level play in crucial moments.

Linton/HMB's strong showing at state was reflected through the selection of two Lions: senior Makiah Ryckman (12) and sophomore Bobbie Janczewski (10), both recognized for their dynamic contributions on both sides of the ball.

Rounding out the All-Tournament roster were athletes who made major impacts for their respective teams.

Our Redeemer's senior Brooklynn Roedocker (12) brought leadership and timely playmaking, while Surrey senior Mekenzie Neighbors (12) earned recognition after an impressive postseason finale.

The NDHSCA also awarded Jacie Connell of Medina-Pingree/Buchanan with the 2025 Division B Coach of the Year honor, celebrating her leadership and the program's continued excellence throughout the season.

Altogether, this year's All-Tournament selections highlight the depth, talent, and competitive spirit that define Division B volleyball, and the athletes who rose to the occasion when it mattered most.

Underwood City November Meeting

The Underwood City Commission met on Tuesday, November 10, 2025, at 5:58 pm at city hall. Commissioners present; R. Kapanke, D. Fischer, D. Saxberg, P. Cabrera, and B. Sayler, Absent: None.

Addition of Stevie Fischer tree trimming and Christmas bonuses

Cabrera, Sayler moved to approve October 21, 2025 meeting minutes, motion carried.

Cabrera, Saxberg moved to approve monthly financial statement, motion carried.

Tom Klabunde and Mara Boone, with Moore Engineering, were present at the meeting. Klabunde informed the commission that the new water tower is up and online. Demolition of the old water tower is complete. Klabunde informed the commission substantial completion and final completion dates have been passed. Liquidated damages are being withheld in the amount of \$78,000.00 from Maguire Iron. Maguire Iron submitted Pay Application 14 for \$24,900.00, with liquidated damages being withheld. Saxberg, Sayler motioned to approve Maguires Iron's Pay Application 14 in the amount of \$0.00 due to \$30,000.00 deduction from liquidated damages, motion carried. Klabunde submitted Maguire Iron's Change Order 3 for fire hydrant extension at water tower site. Fischer, Saxberg motioned to approve Maguire Iron's Change Order 3, motion carried. There were 7 water main breaks due to the new system pressure. Cabrera, Saxberg motioned to approve Change Order 4 for water main repairs in the amount of \$73,614.50, motion carried. Klabunde informed the commission of gate valve replacement being eligible for funding. Proposed cost for 6" valve - \$10,795.00 each, 8" valve -\$12,795.00 each. This does not include asphalt /concrete repair, Saxberg. Sayler motioned to approve the gate valve replacement, motion carried. Tand Construction submitted Pay Application 6 for \$73,614.50 for water main breaks and release of the \$15,000.00 retainage. Fischer, Cabrera motioned to approve Tand Construction Pay Application 6 in the amount of \$88,614.50. Boone submitted the Resolution of Governing Body allowing City Auditor Heidi Krantz to sign documents for Funding Agency. Sayler, Cabrera motioned to approve Resolution of Governing Body, motion carried.

Auditor Heid Krantz presented the corrected annexation resolution on the Industrial Park for signatures Roxanne Kapanke and Courtney Adams.
Public Works Assistant Amy Riddle

informed the commission of the orange salt truck is out for winter use. A hose has been fixed and U-bolts picked up for repair on the salt truck. They have the tank out of the work truck and will be putting the sander in and will need to have braces welded in to hold to sander. Brought the bobcat to the City Hall to see if that can be used for snow removal but it is too big and will need to use the snowblower instead. Public Works has winterized some of the fire hydrants. Painting has been done on the water tower and grass seed has been put down. Guy Brandt cut trees down near the lift station behind his property. Rich Hollesen told Brandt that the city would haul the trees to the landfill.

Cabrera advised the commission that he has 1 load of tires hauled to Mandan and will be hauling loads as he can. Since this issue is being resolved. It will be removed from the agenda going forward.

Krantz let the commission know that insurance with co-ownership is possible with the McLean County Racers Association of the Grader. We could go into contract with the McLean County Racers Association, but we don't know the legalities at this time. We would have to come up with stipulations for in the contract and consult legal to do that.

The commission discussed the proposed ceiling tile replacement in the City Hall and gym tile and mastic removal at the City Hall by Andrus Construction. Cabrera, Saxberg motioned to approve the textured white panes cost of \$4.872.20. with labor cost of \$11,760.00, totaling \$16.632.20. Labor cost would include picking up new material, removal of old material, dump fees, fuel cost, rental fees and clean up motion carried This will be done in December 2025. Saxberg. Cabrera motioned to approve the removal of the gym floor tile and mastic removal at \$4.00 per square foot for a total of \$18.816.00. This will be done in 2026 when we can correlate a time with Andrus Construction and Concrete Coating Specialties motion carried

Sayler requested a look at why idle hours are so high on the loader. Adams presented a list to the commission from January 2025 to October 2025 of list hours. There is a setting in the loader system that can set the loader back to shut off when idle for more than a certain amount of time. Riddle has been asked to pass along to Hollesen.

Patti Armstong has been in contact with the City regarding "My Hometown" series on BEK Communications. Fischer, Cabrera motioned to move forward with "My Hometown" commercial for the City as long as Armstong can find all funding sources, motion carried.

Adams will be working on ordinances in December, starting with the Traffic Ordinance. Then working on the rest from there.

2026 wages will be discussed at the next meeting. The Christmas bonus proposal of \$250.00 per employee. Auditor will be looking into the budget for support. Tabled until next meeting.

Cabrera, Fischer motioned to approve Auditor Heidi Krantz to be added as New Card Administrator under the Purchasing Card Administrator Change Request with \$20,000 monthly and \$8,000 daily limit, motion carried.

Stevie Fischer would like to remove pine trees next to curb. There is no issue

with this, and Fischer can remove those as seen fit.

Saxberg, Fischer moved to approve bills. motion carried.

Next commission meeting on Tuesday, December 16, 2025, at 6:00 pm.
