CITY OF ZEELAND REGULAR MINUTES MARCH 11, 2025

The regular city council meeting was called to order by Mayor Lacher at 7:00 p.m. Roll was called, Todd Dohn (P); Travis Stahl (P); Alfred Schumacher (P) and Ryan Pfeifer (P). Others present were Aidan Kelly, Heartland Garbage, Trash LLC and Brad Williams.

At this time Aidan with Moore Engineering presented awards for the bids for the water project. Circle Controls was awarded the base bid and alternate Dohn made a motion to award Circle 1. Controls the base bid and alternate 1 for \$293,147.16, second Pfeifer and carried unanimously to approve. Schumacher made a motion to approve giving authority to the mayor and auditor to execute contract documents, second Stahl and carried unanimously to approve. Moore Engineering and auditor have been working with the state updating financial information for the SRF loan.

Next garbage contractors presented their information. The city's garbage contract has expired. Heartland Garbage

out of Mobridge their quote after using the residential numbers that were given at \$2,340.00 for a 3 year contract. Trash LLC handed a sealed bid to the mayor. After reviewing Trash LLC offered a 3 year contract for \$2,300.00. Dohn suggested being able to discuss this later in the meeting. Both garbage contractors left the meeting.

The owner of Sportsman's Den, Brad Williams wanted to discuss his water bill. In December the café had a frozen pipe and when meters were read had used an excessive amount of water. He felt that since he has been paying his month since his purchase and has not been open that council should consider waving some of his bill. After discussion council reiterated the fact that everyone is charged the basic rate. Schumacher made a motion to give no forgiveness on the water bill for the Sportsman's Den, second Dohn. All aye. Williams left the meeting.

Minutes from last month's meeting were read. Schumacher made a motion to approve the minutes from the February 11, 2025 meeting, second Stahl. All aye. Financial reports were presented.
