The Wolves (20-14), who advanced to the region tournament for the third straight season, took on District 1 champion Hankinson (24-6) in the opening round of the Region 1 Tournament, Nov. 10, in Jamestown, and results of that match can be found elsewhere in this week's edition of the Emmons County Record. Ellendale ended its season with an 18-13 record.
