
Infographic: US data centers--where are they, and how to they correspond to electricity cost increases since 2020?



This graphic is part of an article published November 4, 2025 in the Investor's Observer, which credible reports describe as "a reputable mid-tier tool for retail investors" that has been operating since 2025. The article argues that within the last five years (which correlates with a rapid increase in data centers), most states have also had a significant rise in consumer electricity costs. What caught our eye was the state of North Dakota, which IO's data shows having had no electricity cost increase.

Information about the number and location of data centers is hard to come by, and there is more than one way to calculate electricity rates.

Nevertheless, according to Grok AI, "Yes, the claim is largely true — North Dakota has experienced essentially no significant net increase (or even a slight nominal decrease in some periods) in average residential electricity rates from August 2020 through much of 2025, keeping it among the lowest in the nation."

This answer accords with other information we have gleaned over the years from mainstream publications and electric industry reports. For consumers in our state, it is good news, and something for which we might want to give thanks this season.
