There is a cost share program through the state which matches what is going to be collected in assessments. Discussion followed on whether the commission wants to have them plan for the snagging and clearing project this year. 

The total beginning valuation for commercial property prior to adjustments by township and city boards of equalization was \$160,380.959. After all including changes, supplementa adjustments, the final valuation was \$163,315,939 which is an increase of 1.830%. This puts Pembina County within tolerance at 91.7%

The average value per acre for all agricultural land was \$1,286.87, as calculated by the Agribusiness and Applied Economics Department at North Dakota State University. The average value per acre in Pembina County was \$1,211.26, a decrease of 5.875%. This puts Pembina County within tolerance at 94.12%

She stated to keep in mind that the percentages provided are rounded.

In 2024, we had 167 applications that qualified for the Homestead Credit Program. As of May 8, 2025, we have received 183 qualifying applications. Additionally, as of May 8, 2025, we currently have 54 veterans enrolled in the Disabled Veteran's Credit Program.
