Public Comment Opportunity – Falkirk Mine Emergency Coal Lease and Federal Mining Plan

The Bureau of Land Management (BLM) and the Office of Surface Mining Reclamation and Enforcement (OSMRE) are seeking public comments on a proposal to lease federal coal and a federal mining plan for the Falkirk Mine in McLean County, North Dakota.

The agencies have issued a draft environmental assessment (EA) analyzing potential impacts from leasing 755.74 acres of federal coal to the Falkirk Mining Company, and a proposed federal mining plan decision that would authorize mining of federal coal over a 15-year period. Additionally, BLM is seeking public comment on the maximum economic recovery (MER) documentation associated with this lease, which evaluates the potential economic recovery of the federal coal deposits.

The lease area contains an estimated 11.3 million tons of mineable federal coal. The lease would support continued coal production to meet the region's baseload electricity needs and help maintain energy reliability for the Upper

The proposed lease is adjacent to the existing Falkirk Mine near Underwood, North Dakota. The coal within the lease boundary is federally owned and falls within the current mine permit area. The mining plan concerns the development and recovery of federally owned coal within the approved permit boundary.

A Notice of Availability was published in the Federal Register on Friday June 20, 2025, launching a 14-day public comment period. Project materials, including the draft EA and MER documentation, are available for review on the BLM National NEPA Register at https://eplanning.blm.gov/eplanning-ui/ project/2037729/510. Comments can be submitted online using the "Participate Now" option (preferred) or mailed to Tessa Wallace, BLM Solid Minerals, 5001 Southgate Dr., Billings, MT 59101.

The BLM and OSMRE will consider all comments received during the public comment period before making final decisions on the proposed leasing action and mining plan for Falkirk Mine.
