WRT board appoints Engelstad to District 4 director seat

Jon Engelstad is the new member of the WRT Board of Directors. Engelstad is the new District 4 director, with his term effective Oct. 31 and will run through June 2026. Engelstad fills the unexpired term held by Hebron resident Joy Kitzan, who resigned at the end of the July, due to moving their primary residence out of the WRT service area.

WRT District 4 represents parts of Morton and Stark counties in North Dakota, including the parts of the St. Anthony, Flasher, New Salem, Glen Ullin and Hebron exchanges lying within those counties south of Interstate 94. WRT members living in District 4, who were interested in filling the unexpired term, went through an application and interview process with the WRT board search committee.

Along with being a qualified WRT member, Engelstad provides a great understanding of servant leadership and community involvement. Engelstad is a deputy sheriff with the Morton County Sheriff's Office. He has more than 25 years of service in law enforcement, including as an investigator, K-9 handler, patrol deputy and member of the West Dakota SWAT - CNT as a negotiator. Engelstad also serves on the Morton County Sheriff's Office Search & Rescue Dive Team and the New Salem Ambulance. He is originally from Bottineau

and has been a resident of Morton County for more than 25 years. Engelstad and his wife, Allison, have six children. "I value the cooperative spirit, neighbors working together, sharing ideas and supporting one another," Engelstad said. "It's inspiring to see how our shared efforts make a real difference and I'm proud to play a role in keeping our co-op strong for future generations."
