# Slugs take 3 of 4 games

Bottineau's Babe Ruth baseball team is fresh off a successful week, taking three of four games.

After dropping a 1-0 decision last Monday against Cando, where the DiamondSlugs outhit Cando 3-2 but still lost, Bottineau bounced back with two blowout wins Thursday against Dunseith.

Three RBIs from Dawson Guss, plus two apiece from Mason Lauckner and Austin Getzlaff, saw Bottineau roll to a 14-4 win in Thursday's opener, before Clint Seykora drove in three runs in a 19-4

win in the rematch. Tyson and Austin Getzlaff drove in another two runs each.

Seykora then went the distance on the mound in a 15-0, four-inning win Friday at Harvey. He struck out six batters and allowed just one hit. Bristol and Griffin Reitan had three RBIs apiece from the Nos. 1 and 3 spots in Bottineau's lineup, while Guss and Mason Bristol added two RBIs apiece.

Bottineau was scheduled to host Devils Lake this Monday after press time. The Slugs host Rugby on Tuesday before visiting Devils Lake on Wednesday.

"I used to go to the national meetings all the time, and they've now moved their offices from Colorado to Charlotte, so it's different," said Rybchinski, who led DCB to seven NJCAA national titles, including the last-ever junior college hockey championship in 2016.

"They've gotten to a higher level with marketing and business and everything. It's not just a small operation anymore, but a pretty big business, and it was cool. They did a really nice job, and their new president (Christopher Parker) wants to honor the past, so that's why they did what they did.

"There might've been one or two other sports that the NJCAA doesn't have anymore, whose coaches they honored, and it was just like with every other sport," Rybchinski continued. "The message they harped on was that they want to honor their legacy, and they keyed on the coaches. It was pretty neat."

Warren spent 16 years behind DCB's bench, leading the Jacks to NJCAA national titles in 1986, 1991 and 1998. He later served for nine seasons coaching at Minnesota Crookston, and in 2019, he joined UMC's Athletics Hall of Fame. In total, he spent 37 years in college athletics, either as a coach or as an administrator.

Rybchinski's NJCAA-era teams included 42 junior college All-Americans and 22 NJCAA Academic All-Americans. He also earned seven NJCAA national tournament coaching awards.

It's coming up on 10 years since DCB switched, out of necessity, to the American Collegiate Hockey Association, which is almost exclusively made up of member teams from four-year institutions.

"I hadn't really thought of those days until I was there, seeing the NJCAA logos and a 20-foot inflatable version of a NJCAA national championship trophy," Rybchinski said of the Charlotte trip. "It was a really good feeling to be there, and I wish we still had NJCAA hockey, but it is what it is, and I think we're good where we're at, but that brought a lot of good memories back. "A lot of it for me was remem-

bering players we've had in the past. We've had such good guys, and guys who I coached in my first few years have kids growing up now, and it's crazy how long it's been. We had some really good times out there, and a guy I sat beside at our table was from Broome (N.Y.) Community College, and we talked about how they hosted nationals. It was neat to remember that, because that's where we won our last title.

"This was just a neat way to cap all that off," Rybchinski continued, "because when (NJCAA hockey) was done, I felt I might not ever hear from the NJCAA again, but it was a good honor to receive.

"We are lucky at DCB, because our community and administration have really supported hockey over the years."
