Gaming For All: How One Club Is Using **Assistive Technology To Open New Worlds For Individuals With Disabilities**

Advocacy, we believe everyone deserves the opportunity to live, connect, and play as independently as possible. Sometimes, that journey begins with a single, powerful question: "Can you help me play video games?

That question came from a student at the Anne Carlsen Center in 2019. He had spent years watching his brother enjoy video games but couldn't join in due to physical barriers. Determined to find help, he turned to Marcy Szarkowski, an Assistive Technology Professional at Anne Carlsen. What started as a simple request became the spark for something transformative, the creation of the Gamers Club.

The Start of the Gamers Club

Marcy wasn't a gamer at the time, but she knew the importance of inclusive recreation. She bought a used Xbox and began learning the ins and outs of gaming herself. Her goal was to understand the player experience and find a way to break down access barriers using assistive technology.

She discovered the Xbox Adaptive Controller, a highly customizable piece of hardware developed by Microsoft for people with limited mobility. With ports for external switches, buttons, and joysticks, it gave Marcy a flexible tool to meet a variety of needs. From there, she began building custom gaming setups using a mix of adaptive switches,

At North Dakota Protection and modular hoses, head mounts, and even 3D-printed tools. Each configuration was uniquely tailored to the student's physical abilities and preferences.

Her efforts led to the launch of the Gamers Club, an inclusive weekly gaming group where students with and without disabilities could gather, play games, and build friendships.

More Than Just a Game

"Gaming is such a social thing," Marcy explains, and that's what the Gamers Club is truly about, connection. Held once a week, the club creates a welcoming space where individuals of all abilities can come together to enjoy video games, whether they're experienced players or just excited to be part of the fun. It's not just about playing, it's about inclusion, confidence, and joy. During the COVID-19 pandemic, the club shifted to a virtual format, but the return to in-person meetings brought back the full energy and camaraderie that made the club special. Today, the Gamers Club welcomes participants from both inside and outside the Anne Carlsen campus.

From Spectator to Champion

The student whose question inspired it all has since become one of the Gamers Club's most successful members. After gaining the ability to game with assistive technology, he continued to build his skills and confidence. In 2024, he won

Prairie Fare: Pink Teeth And Plaque, **How To Nourish Your Smile For Life**

NDSU Extension "You have pink teeth!" someone

said with a giggle. We grinned at each other to show

off our rosy-colored teeth. We were elementary school students using "disclosing tablets." Most of us had teeth the color of bubble gum, unfortunately.

Having pink teeth was not good. It meant we were neglecting our dental hygiene, the red chemical in the tablets attached itself to the plaque on our teeth.

Plaque is a sticky coating made of bacteria that forms on our teeth. Technically, it's a "biofilm," and it's the main reason we need to brush and floss our teeth daily and have professional dental cleanings.

If you run your tongue over your teeth, they might not feel smooth if

you have plaque. Without regular brushing, flossing and routine professional cleaning, that means cavities, gum disease, infections or tooth loss can occur in adults with time. When you visit your dentist twice a year, this health professional will examine your gums, tongue and the rest of your mouth for signs of cancer.

Dental pain or tooth loss can affect your ability to chew and enjoy food.

Poor oral health can also affect our overall health, and it may increase our risk for heart disease and heart attacks.

Besides oral hygiene, the food we eat can affect our dental health. Bacteria on our teeth love us when we eat sticky, sweet foods, but our teeth will suffer from the exposure.

Food labels now list "added sugars" and "total sugars." Limit the amount of foods with added sugars to protect your teeth. Consider rinsing your mouth with water if a toothbrush is not nearby.

Staying well-nourished is essential for our overall health, including the health of our mouths. Strong, healthy teeth allow us to eat a variety of foods without pain. Chewing is the first stage of digestion.

Nourish your teeth with a calcium-rich diet. Dairy foods such as milk, yogurt and cheese are among the best sources of calcium. Nutrition experts advise about three servings of calcium-rich dairy, or an al-

ternative, every day. Beware of sweetened carbonated beverages because of their added sugars and the additional ingredients they contain, including phosphoric and citric acid. These two acids in many beverages can pull calcium from our teeth.

Instead of soda, have plain water. Avoid chewing ice cubes, because they can damage our teeth.

If you're craving something sweet, consider treats made with Xylitol, a sugar alcohol that may reduce cavity risk. But a word of caution: Xylitol is toxic to dogs, so keep it away from pets.

Eating plenty of vitamin- and fiber-rich crunchy vegetables also can help us maintain our oral health. The fiber in celery, for example, acts as a natural toothbrush.

Vitamins A, C and D are especially nourishing for our teeth and our body. Enjoy some seasonal produce such as strawberries, tomatoes and bell peppers to boost our vitamin C. Milk is fortified with vitamin D, which helps us build and maintain strong bones and teeth. Vitamin D is naturally found in salmon and other fatty fish.

Be sure to get your fluoride

through water from most municipal supplies or fluoridated toothpaste. Fluoride is important for keeping our teeth strong.

As I was thinking back to my childhood experience with disclosing tablets, I discovered they are available online. Try it out if you

want to check if your teeth turn pink with these tablets. However, your best option is good nutrition paired with regular brushing, flossing and dental visits.

Yogurt Dip 1 apple, sliced

1 banana, sliced 1 orange, peeled and separated into slices

½ cup orange juice

1 cup vanilla yogurt (or soy yogurt for dairy-free option) ½ teaspoon cinnamon

Wash and prepare fruit. Pour orange juice into a small bowl. Dip fruit pieces into the orange juice to prevent browning. Arrange fruit on a plate. Mix the yogurt and cinnamon in a small bowl. Arrange the fruit around the bowl of yogurt and cinnamon dip. Serve with toothpicks or forks.

Makes four servings. Each serving has 120 calories, 1 gram (g) fat, 4 g protein, 27 g carbohydrate, 3 g fiber and 40 milligrams sodium.

ND To Boost Awareness Of SNAP Acceptance At Farmer's Markets ers markets accept SNAP, program By Mike Moen,

When North Dakotans head to farmers markets this summer, they might want to see which ones accept SNAP benefits, as the state is enhancing a search tool so that those eligible can stock up on fruits and vegetables.

EBT cards distributed through SNAP are now accepted at thousands of farmers markets across the country. North Dakota's agriculture department has updated its online Local Foods Map to indicate which locations within the state are part of the SNAP network.

Keith Knudson, executive director of the North Dakota Farmers Market and Growers Association, said it is another way to improve access to healthy food. "We're seeing a lot more of those farmers markets in rural areas where we have issues with not having enough fresh vegetables in the community," Knudson


He pointed out small town grocery stores have struggled to stay open and if those new rural farm-

recipients have a dedicated source of fresh food for the season. Knudson noted it has been hard for some operators to implement SNAP payment systems but added the program is making improvements. On the updated map, a yellow star shows which markets are SNAP sites.

EBT users visiting farmers markets can stretch their benefits further through incentives. The "Double Up" option provides a dollar-fordollar match for purchases of fruits and vegetables, meaning low-income residents can load up without depleting their account.

Doug Goehring, North Dakota's agriculture commissioner, hopes the feature boosts awareness and activity. "Once they know that, maybe they'll seek them out, and it'll encourage more and more people to consider going down the road,' Goehring stressed.

Agriculture leaders said increased program activity not only helps the SNAP recipient but also the local vendors by expanding their customer base.
