Delinquent water bills were discussed and 6 door tags will be sent out.

The police report for June was reviewed.

There was no court report from June.

City Engineer Jason Gerving was not present but had spoken with Auditor McCutchan stating that the Summit Avenue project is still expected to begin mid-August.

Supervisor Chad Stern discussed with council that he had dug up the service line on south Park Street and found corrosion was what was keeping the water service from working. The repairs have been made and as soon as Supervisor Stern can install a new meter the service will be switched over from the Hebron Herald property to the other property owner. Stern stated that the park shelter will be hooked to temporary water for the Hebron Watermelon Days.

The WRT contract was discussed and Attorney Solem presented Ordinance 25-03 including a clause stating that the city may impose a franchise fee pursuant to NDCC Chapter

49-21. The first reading of Ordinance 25-03 was held and a motion was made to approve the first reading. Dittus/Hong MCU. The second reading of the Ordinance 25-02 amending the Midco franchise was held and a motion was made to approve the amendment. Tibor/Dittus MCU.

The Planning and Zoning Board was discussed and a motion was made to appoint Laszlo Szalanczy to the Planning and Zoning Board. The Home Rule Charter Committee was discussed and will be looked at again in the future. Bulk sewer rates were discussed.

Auditor McCutchan stated that a company working for the Country Fest in New Salem had contacted the city regarding dumping waste into the sewer. McCutchan stated that the ordinance regarding sewer rates states nothing concerning bulk waste water disposal and could only quote the price for residential fees. McCutchan stated this should be looked at in the future, as something should be put in place similar to the bulk water rates that exceed the standard rates paid by residential and commercial properties in town. The matter was tabled for later discussion.

Supervisor Stern stated that he would like to coordinate with the contractors doing the work on Summit Avenue to see the cost of doing some street patching where there have been water line repairs and the street has been dug up. McCutchan stated she had mentioned this to City Engineer Gerving and he stated that Stern should give him a call to discuss the matter further.

The reinstatement of the Renaissance Zone was discussed as the program had expired in June. The program offers tax incentives for property rehabilitation and new construction. A motion was made to reinstate the Renaissance Zone. Hong/Tibor MCU.

Auditor McCutchan stated that she would like to set up a meeting with the budget portfolio to go through the budget for 2026. Preliminary budgets are due in August. McCutchan will contact the portfolio members to set up a meeting for the budget.

The Council meeting adjourned at 7:30 pm. Tibor/Hong MCU
