## JetX-PSC

A coalition of five townships, landowners, and other interested parties have hired a law firm from Minneapolis to litigate the petition to the North Dakota Public Service Commission to rescind the permit it allowed earlier for a JetX power transmission line to be built between Ellendale and Jamestown.

This project was approved by the PSC in November of 2024 on a 2-1 vote. Randy Christman wrote in his dissention that he had not heard any justification yet. He did not believe that the problems exist on the need for the power line.

The petition is to intervene, rescind, and reopen proceedings for the JetX case. The petitioners would like the case re-opened to provide procedural due process, complete the evidentiary record, and fully consider new and material evidence bearing on the public interest.

The main argument from the petitioners is that JetX has failed to provide justification that it will be for public convenience and necessity. They also claim that there is no public need for the line. Between what the petitioners say is a string of procedural and legal errors and what they say is new evidence coming forward, the PSC must look at this permit again.

The petitioners also believe that when the PSC made their decision to grant the permit, they relied on misrepresentations and omissions, and the power company was vague when asked key questions.

The Public Service Commission does not have any obligation to review the permit. The case may never be re-opened.
