The City's RZ was established pursuant to chapter 40-63 of the North Dakota Century Code for the purpose of encouraging economic development in the City. Property and income tax incentives are available to projects within the RZ for large capital improvements to residential and commercial property, new residential and commercial construction, and in limited cases commercial leases and relocation of commercial enterprises. The City's Development Plan for the next 10 years proposes to delete some areas within the RZ and expand to new areas identified for development, while keeping most of the existing RZ in place.

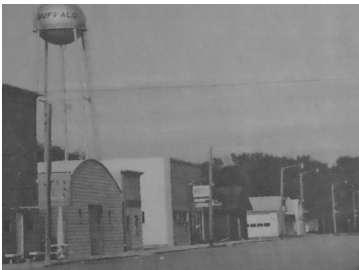
