Notice is hereby given that on July 23, 2025 at the polling place of the Page Fire Hall, 114 Morton Avenue, Page, ND 58064 an election will be held in which the following question shall be submitted to the electors of the Page Ambulance District.  
**Shall the Page Ambulance District be authorized to levy a tax not to exceed fifteen (15) mills for the purpose of funding a rural ambulance district?**

The Page Ambulance District is a newly established rural ambulance district formed on August 7, 2024. The Page Ambulance District currently has no taxing authority. A “Yes” vote means you are in favor of granting the Page Ambulance District taxing authority of up to fifteen mills per year. A “No” vote means you are not in favor of granting the Page Ambulance District taxing authority of up to fifteen mills.

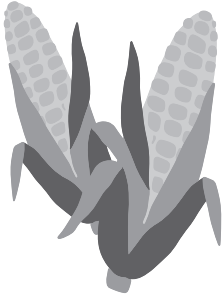
