He said one of the pipes directly adjacent to the water tower broke and a significant water loss occurred, causing loss of pressure throughout the entire water distribu-tion system. He said they were able to get the break isolated and pressure re-stored in a couple hours. As standard stored in a coupe hours. As standard procedure, due to the loss of pressure a boil order had been put into effect un-til the City passes a water sample test. The Assistant City Engineer said samples were sent to Bismarck earlier in the afternoon and they are working closely with the Denortment of Envire. In the arternoon and they are working closely with the Department of Envir-onmental Quality. He said they are hoping to get information on the test results tomorrow afternoon but that a boil order is in place until further no-tice. He added that relevant informa-tion is posted on the City's website tion is posted on the City's website. President Moe thanked all City staff that aided in the response to the water break and the business owners that provided food and beverages to the City workers. Commissioner Knowski said they would receive a lot of praise for being first responders and he wanted to make sure the utility crews don't feel like they are taken for gran-

ted. President Moe asked about the level of water loss that occurred during the event. The Assistant City Engineer said the water tower holds 500,000 gallons and that it was emptied, so the water loss is expected to be greater than that at a minimum.

The City Administrator thanked the City Engineer and Utility Departments for the expertise and confidence with which they handled the problem with. Commissioner Hach – The Assistant City Engineer said the Sanitation crews were doing a double route today deswere doing a double route today des-pite the bitter cold and thanked them for their service to the City.
