the project, the City has put forward a sales tax proposal that will be before City of Devils Lake residents on July 22, 2025. Halvorson said, "That's a proposal that has multiple parts to it, but this Police Department relocation is a major piece of that proposal, as well as trying to ensure the long-term viability of our current public safety service levels. Bringing in a little over \$2 million in property taxes and spending around \$4.5 million on public safety will not be sustainable without an additional revenue stream. Over the next month and a half we will have a lot of community engagement on that front and we look forward to answering questions City residents may have."

it's currently structured," Halvorson stated.

A big concern for the City, he says, is the amount of space the Police Department has and the absence of garage space for police department vehicles and equipment.

"They are cramped for space as it is there. There is no garage space and they have very limited evidence storage space. We have 14 squad cars and no garage space, which is really hard on our vehicles, as well as our officers who have to start the vehicles, sometimes clean the vehicles outside when it's 20 below. There is also \$20,000 in electronic equipment in each patrol vehicle. So, it's not really a good quality of life for our officers or good for our vehicles or equipment, which leads to maintenance issues and higher costs. Anyone who has had their car worked on the last five years knows how expensive it's gotten and the City is paying that increase on 14 squad cars that sit outside all winter long," Halvorson said.

When asked why the City wouldn't want to have the Police Department included as part of a potential new Law Enforcement Center facility, he said unknowns and expected cost increases make it evident that having the Police Department detach from the LRLEC may be in the best interest of the

City. "We've been told that a new LRLEC facility without the Police Department in it would reduce the cost of the project by around \$10 million dollars. We could build or buy a facility and fit it to our needs for well under that. Not to mention the long-term operational costs. We pay \$60,000 in a lease payment for our current space. Preliminary estimates provided to us indicate our yearly lease payment would double. So if we can save a bunch of money on both the initial capital and long-term operational costs, it seems like a financially wise thing to explore,' Halvorson continued. "Not to mention

location. It is likely a new LRLEC would be on the fringes of town because of the greenspace required and the overall size of the facility. We could potentially centrally locate the Police Department downtown which would assist with the conversations around downtown safety the community has been having for a while. Plus, and I know this is important to Chief Toso, is the proximity to the school district properties and the hospital. So in the grand scheme of things, and I know the Commission views this town for both. The as important, if we can save a bunch of public resources on building costs and operational costs, and all the while put the Police Department in a more strategic place in town, we wouldn't be doing our jobs if we didn't explore it," Halvorson added.

"Another factor is the unknowns on how a new LRLEC would get across the finish line. There are people at the LRLEC and County that are work-

ing hard on the issue and it's a thankless iob. But there isn't a firm financial plan to pay for a new LRLEC. The County is exploring home rule, which is a long process that has been unsuccessful in the past and then they're exploring a 1% sales tax. But the sales tax wouldn't be enough to cover a 30-year bond payment on a \$60 million plus facility. Then you're talking multiple years to build a new facility. The unknowns and timelines are concerning. Given everything, it is important that the City takes ownership and grabs the steering wheel when it comes to the space for our Police Department to oper-

ate," Halvorson said. If the Police Department was to relocate outside of the LRLEC, selecting a new site would be an important order of business for

the City Commission. "We are analyzing locations where the Police Department could go. We could build new or buy an existing building. There are options in City has land in strategic locations around town and there are a few buildings for sale that could potentially work. We've reached out to a few owners and explored options."

Halvorson said. During the Journal's conversation with him, he said the City's original idea of moving the Police Department to the existing City Hall location and then moving City Hall to a different location downtown has been put on

the backburner.

"We were hoping such a project would be somewhere between \$4-\$6 million. We did the research on that and had some architects do some cost analysis and it's looking like it'd cost more

like \$6 to \$8 million. Adding, "I think its important to adapt as information comes in and while the concept was sound, we can probably get a better return on investment with a different strategy. In talking with Mayor Moe, we've kind of put that idea on the shelf and it is likely we'll propose keeping City Hall in its existing location and remove its relocation from consideration for now," said

Halvorson. One of the biggest factors in determining a location is knowing how big of a building the City will need for the Police Department relocation.

"We were intentional on defining the scale for the project and have made progress on that front. Obviously, the Ramsey County Sheriff's Office is in the same position our Police Department is. Both the Police Department and Sheriff's Office like being in the same location. We had some dialogue with officials at Ramsey County. They made it known they were not interested in separating the Sheriff's Office from the LRLEC. That has provided clarity to the City despite what I think could have been some efficiencies and cost savings created by working together. I wish they would have

With what he described as clarity on defining the scale of the proposed relocation, he says the City ties for sites that could accommodate just the Police Department.

"There are opportunities downtown. I know the City Commission is genuinely interested in what the residents of Devils Lake think in regards to a potential future location. Should location be prioritized or cost? If it cost a little more to relocate downtown compared to a different location, would that be worth it? Those are real policy decisions the City Commission will have to make. From talking with them I know they really want to get the


