HETTINGER HOUSING: Kyle Wilson has started as the new manager. Council Member Parrill discussed maintenance and upgrades being planned.

SHANNON HEWSON: with Brosz Engineering met with the Council briefly to thank them for the past year working together on engineering needs. Discussion was had on when to start the bidding process for Airport Road. Possibly trying to "piggy-back" with chip sealing projects in the City of Bowman, so hopefully can get more bidders interested.

CURB AND GUTTER INITIATIVE PROGRAM: Council Member Parrill discussed areas around the school is still requiring curb and gutter.

USDA COMPLIANCE: Mayor Lindquist has been working with Ms. Schalesky and the two contractors to complete necessary ADA work. The work will start at any time.

HETTINGER SCHOOL ARMORY USE AGREEMENT: This agreement was signed by the Council in September but has not been signed by the school yet. Council Member Parrill discussed; after visiting with the school, he has drafted changes and clarification to wordage

about damages that may happen to the building.
2024 YEAR END BUDGET AMENDMENT: Council Member Parrill moved to amend the 2024 budget for the General fund in the amount of \$37,968.69. The Capital Improvement fund in the amount of \$268,833.95 (water meter system) and Sales Tax fund in the amount of \$195,345.00 (KMM building purchase) The motion was seconded by Council Member Gaylord, and by unanimous vote; motion carried.

2024 YEAR END TRANSFER: Council Member Parrill moved to approve the transfer of \$22,854.14 from the Capital improvement #2 fund into fund 806 Special Street Improvement fund. The end balance of the Capital Improvement #2 fund is \$25k, as previously approved. The motion was seconded by Council Member Ebert, and by unanimous vote; motion carried.

DISTRIBUTION OF CHARITABLE SALES TAX: One request was available for review from the Hettinger Junior after prom students for \$2k. Council Member Parrill moved to approve the one request, second by Council Member Ebert, and by unanimous vote; motion carried.

DISTRIBUTION OF INFRASTRUCTURE SALES TAX: Four requests were available to review. Two from WRHS, one from the fire department, and one from the school for the swimming pool. Council Member Gaylord moved to approve a donation in the amount of \$500 for the purchase of equipment with the Grateful Givers, and \$5k to the WRHS for the renovation of the obstetrics wing, and \$20k to the Hettinger Fire Dept, second by Council Member Burwick, Council Member Gaylord moved to approve paying the

\$40k to the school for the pool, second by Council Member Ebert, and by unanimous vote; both motions carried. Discussion was had on the reduction of funding for ACDC and Chamber offices, as the City reduced their funds to \$30k from \$40k. The reduction in funds caused issues between the ACDC and the Chamber. Council Member Burwick moved to approve the \$10k from infrastructure funds this year to the Hettinger Chamber, second by Council Member Ebert, and by unanimous vote; motion carried.

DESIGNATE DEPOSITORIES: Council Member Ebert moved to designate Dakota Western Bank and Dacotah Bank, both of Hettinger, as depositories for City public funds for the 2025 calendar year, second by Council Member Gaylord, and by unanimous vote; motion carried.

ORDINANCE GRASS CLIPPING SITE - FIRST READING: An ordinance was drafted by the City Attorney stating the rules of the grass clipping/branch site. The branch size is clarified as no more than 6 inches in diameter. The violation would have a penalty of \$250 per instance. Several changes were discussed, and the first reading will be next month.

REQUEST FOR TABLES & CHAIRS RENTAL - OFF PREMISES: A request from Terry Lien was reviewed for the rental of the Armory tables and chairs October 2025 for a wedding. The Council discussed a deposit, and a contract would need to be signed along with the per item rental fees. Council Member Parrill moved to approve the rental with the need of a signed contract and required deposit. Mayor Lindquist will talk to Terry Lien, the Auditor will request the City Attorney to draft a contract to include deposit, rental, and cleanliness needs.

NUISANCE NOTICES: Two complaints on trash piled up at 505 6th Ave N and 306 3rd Ave. N. Furniture and appliances have been piled up on the property. Council Member Burwick moved to approve Auditor Faller to send the two complaint letters to the owner, second by Council Member Ebert, and by unanimous vote; motion carried.

HETTINGER FIRE DEPT BUILDING: The Capital Improvement has never been charged and should be, Council Member Ebert moved to approve the charges, second by Council Member Parrill, and by unanimous vote; motion carried.

BILLS: Council Member Ebert moved to approve the paying of bills, including approved Sales tax distributions, second by

Council Member Gaylord and by unanimous vote; motion carried.
