ted from Hettinger in 2003, he told the Adams County Record that he was leaving behind a family and a full-time job. He stated that his original home was in Arizona and then those words that struck a chord in one's heart... He said he volunteered to be deployed with the 141st. He was a former Marine and served a number of years with that branch of the military before joining the guards.

Melling said, "Those who come home physically, are never the same mentally." Sadly, those words have been echoed by many veterans. Melling said losing even one soldier to self-harm after returning from deployment is too many. Veterans Day was

named as a salute since 1919 to every veteran and those who continue to serve. A salute to their families who wait for them to return while handling life at home without them.

The history of Veterans Day is laid out historically and in a statement of honor best said by the United States Department of Veterans Affairs' website, "World War I – known at the time as "The Great War" – officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting cea-

sed seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars." Veterans Day continues to be observed on November 11, regardless of what day of the week on which it falls. A celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good."

The Hettinger City Council will hold a public hearing on **November 12, 2025, beginning at 9:15 AM in the Conference Room of the Armory, 1207 4th Ave South Hettinger, ND** to consider the following items:

- 1.Ordinance 2025-03 amending Section 12.0801-Overgrown Trees-Nuisance of the City Code of the City of Hettinger.
 - 2.Ordinance 2025-04 amending Chapter 6-Zoning of the City Code of the City of Hettinger.
- Proposed changes include:
- Spelling, grammatical, and formatting corrections throughout the chapter that do not alter the substantive meaning of any provision
 - Updates to the definitions of "Garage, Private" and "Common Lot Development"
 - Revisions to reflect changes in responsibilities formerly performed by a certified building inspector
 - Authorization for the City to publish a notice of amendment changes in the official newspaper in accordance with state law
 - Clarifications to resolve existing inconsistencies
 - An increase in allowable sidewall height for accessory structures, subject to specified conditions
 - Addition of new permitted uses within various zoning districts
 - Introduction of tree-related provisions aimed at ensuring long-term public safety
 - A new requirement for site reclamation following building removal or demolition
