A semi hauling corn overturned on Thursday morning after failing to stop at an intersection, leading to a crash that temporarily closed a stretch of roadway in Richland

The incident occurred at the intersection of County Road 8 and 81 when the semi failed to stop at a posted top sign and struck a trailer that a pick-up had in tow.

The impact caused the semi to overturn, spilling its load of corn and knocking the trailer into the east and westbound lanes of County Road 8.

Hankinson teacher charged with exchanging explicit photos with student

A high school science teacher at Hankinson who resigned in March is facing charges for exchanging explicit sexual performance photos with a student under the age of 18.

Zachary B. Nelson, 31, was charged with a felony count of luring minors by computer or other electronic means and felony possession of certain materials prohibited.

The charges were filed in Richland County Court by Richland County State's Attorney Megan E. Kummer on Wednesday.

There were 14 witnesses on the court documents obtained by the News Monitor including the victim, whose name was withheld by the courts.

On March 21, Hankinson Public School Superintendent Chad Benson said in a release, high school science teacher Zach Nelson resigned that afternoon. His resignation was accepted by the Hankinson School Board of Education during a special meeting on Monday, March 24.

The News Monitor reached out to Benson for comment in March and did not receive a

The court filing goes into graphic details of the photos. To be charged with luring minors, the law says, "the defendant importuned, invited or induced a person the defendant believed to be the minor to engage in a sexual performance, obscene sexual per-

formance, or sexual conduct for the defendant's benefit, satisfaction, lust, passions or sexual desires and the defendant reasonably believes the minor was (under the age of 18)."

The court papers then described the photos. The newspaper is not publishing that information.

The court filing said the actions took place in Richland County and the charge carries a minimum of one year in prison, five years probation and registering as a sex offender.

Benson said in a Facebook post on the Hankinson Public School District page in March, "There is an active law enforcement investigation into messages exchanged between Mr. Nelson and a student. To avoid harming that investigation, I am unable to share any further information, evidence, or details that are not yet publicly available. The school will be cooperative with law enforcement to the greatest extent

In his statement to the "HPS Families and Community," Benson said, "Mr. Nelson chose to resign from his position with the school district."
