Remains of fetus located in southeast Jamestown, police

JAMESTOWN, N.D. — The remains of what is believed to be a human fetus were found on Tuesday, Nov. 4, according to Jamestown Police Capt. Sidney Mann.

At 2:49 p.m. Tuesday, a construction company called the Stutsman County Communications Center, reporting that while on a project in southeast Jamestown, they believed they had exhumed the remains of a human fetus.

Jamestown police officers responded and located what is believed to be intact fetal remains along with broken pieces of an amber-brown glass container, Mann said. The remains were collected and examined by the Stutsman County coroner and are being sent to the


