The resignation was accepted by the Kidder County Council on Aging Board. Guthmiller would like to continue

with this process and would like a letter of resignation from the Kidder County Council on Aging Board.

Guthmiller read letters of resignation from Thelma Wall, Carl Knutson, Bonney Stroh, Mary Rohrich, Diane Kinnischtzke, Emmons County Anthony Holzer, Mary Baumgartner, and

The Kidder County Council on Aging by-laws state in Article II Section 3 An open position on the Board of Directors must be filled by each specific county whose member has gone off the board. If that position cannot be filled by the existing county member, the position may be filled by appointment of the Council Board or by the Board of County Commissioners.

Rohrich said the Transit van is parked outside and handed in the keys for the van, keys for the senior center, cell phone and passwords to Commissioner Friez. There isn't a driver for the Steele site Transit van right now.
Thelma Wall asked if there was a

possible grant to put cameras on the outside of the building for safety reasons. Discussion held.

Rohrich said the locks on the office doors have been changed today, passwords are for the director's computer, cell phone is for Transit, she also said there are 4 credit cards suggested cancelling these and applying for new ones. Price will need to return the extra van keys and laptop in her possession.
County Commission will appoint a

Kipp requested the 2019 November and December ending balances for the 2020 financial beginning balances and copies of the W-2's. Kipp said checks were held 4-6 weeks before they were deposited and this will need to be cor-

Commissioner Guthmiller said we want support from Burleigh County Senior Adults Program to help get things back in order. Burleigh County still has the contract with Kidder County for Senior Services.

NDDOT has a contract with Kidder County Senior Services for Transit and NDDOT wants the contract reviewed.

There will be a joint meeting on February 10th with the Kidder County Council on Aging and the Kidder Coun-Commissioners at 1:30pm.

Employees were notified of Director Renee Price's resignation today and services will continue as usual.

The new board will be informed there will need to be an audit done as soon as Roggenbach gets the finan-

cials split out according to funds.
Kipp was wondering if the rosters for January were done. Rohrich made a list of employees for Kipp.

Jean Bon and Paula Moch joined

the meeting. Becky Hanson from NDDOT Transit

is sending a confirmation of money to Roggenbach to help with the financials break out. Discussion held

Friez made a motion to nominate Robin Rewald to the Kidder Council on Aging Board, seconded by Dronen, discussion, none, all in favor, aye, opposed, none, motion carried.

Dronen made a motion to nominate Paula Moch to the Kidder Council on Aging Board, seconded by Friez, discussion, none, all in favor, aye, op-

posed, none, motion carried.

Guthmiller made a motion to nominate Jean Bon to the Kidder Council on Aging Board, seconded by Dronen, discussion, none, all in favor, aye, op-

posed, none, motion carried. Commission welcomed new board members.

Guthmiller called for nominations for officer positions on the board:

Bon nominated Robin Rewald for Secretary/Treasurer for the Council on Aging, Moch motioned nomination cease, all in favor, aye opposed, none, motion carried.

Rewald nominated Paula Moch as Chairperson and Jean Bon as Vice Chairperson, seconded by Dronen, all in favor, aye, opposed, none motion

A letter to accept the resignations of the old board members and appointments of new board members was signed by the County Commissioners

for banking purposes.

Moch made a motion to put Rewald secretary/treasurer, Moch chairperson, Bon vice chairperson's signatures on the checking accounts and require 2 signatures on checks, seconded by Guthmiller, all in favor, aye, opposed, none, motion carried.

Discussion was held on filings at the state, by laws, Transit, policy man-ual for employees, salaries, advertising for a new director, and having current employees come to the February 10th meeting.

County Commission wants to over see the board till everything is up and running then have the Council on Aging give a summary and monthly report to the Commission.

Kipp introduced herself to the new board and said the Burleigh County Senior Adults Program holds the contract for nutrition and she over sees the meals and health programs. And she is glad this is happening so quickly and is on board and willing to help get things up and running. Kipp did an onsite visit in Tuttle and Steele and the meal site are in compliance, she received some complaints and those have been resolved. Kipp has concerns on how things are done, the differences in wages and deposits not getting done on time

Kipp also stated the nutrition program is considered federal money and every site should make a deposit once a week. She also explained how the process works

Moch asked for a to do list of things that need to be done and corrected.

Kipp said there are state approved menus and one person should order the food, one person get the food and transit can be used to pick up food in Bismarck.

Rhonda Meier is working with Darla Roggenbuck on the book keeping. Roggenbuck said Meier starting doing the book keeping on January 1, 2025 and is willing to keep doing the books and work with Roggenbuck. Moch said hiring a director is a pri-

ority and also contacting Becky Hanson at the NDDOT about Transit. Bon will contact Hanson at NDDOT.

P & L report was reviewed, 501-3C non-profit was discussed, boards were discussed.

Commissioners Friez will be the liaison between the Council on Aging and the County Commission.
