City of Steele Code of Ordinances

ORDINANCE NO. 177 AN ORDINANCE REGARDING THE USE, REGUALTION AND PENEL- TIES FOR LOW-SPEED VEHICLES BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STEELE, NORTH DAKOTA:

Section 1: Definitions for this Ordinance are as follows:

1. "Low-speed vehicle" means a four-wheeled vehicle that is able to attain a speed, upon a paved level surface, of more than twenty miles [32 kilometers] per hour in one mile [1.6 kilometers] and not more than twenty-five miles [40 kilometers] per hour in one mile [1.6 kilometers] and may not exceed three thousand pounds [1361 kilograms] in weight when fully loaded with passengers and any cargo.

2. "Operate" means to ride in or on and control the operation of a low-speed vehicle.

3. "Register" means the act of assigning a registration number to a low-speed vehicle.

Section 2: Low Speed Vehicles Allowed. Low speed vehicles as defined by NDCC Chapter 39-29.1 are allowed to operate on any city street with a speed limit of 25 miles per hour or less, subject to the following conditions:

1. The low-speed vehicle must be registered in accordance with NDCC Chapter 39-29.1.

2. The low-speed vehicle must be equipped as required by NDCC Section 39-29.1-08 and meet the minimum and maximum speed requirements of NDCC Section 39-29.1-01(1).

3. An operator of a low-speed vehicle may make a direct crossing of a street on which the speed limit exceeds 25 miles an hour if the crossing is made so that the operator can continue on a street on which the speed limit does not exceed 25 miles per hour. A low-speed vehicle may not be operated on any public sidewalk.

4. A low-speed vehicle may be operated only by a person 18 years of age or older possessing a valid operator's license.

5. All other ordinances and statutes regarding the rules of the road generally applicable to motor vehicles and not amended by this section shall apply to the operation of low-speed vehicles.

6. A person may not drive, or the owner may not cause or knowingly permit to be driven, a low speed vehicle in the city without a valid policy of liability insurance in effect, in an amount as required by NDCC Chapter 39-16.1, in order to respond to liability arising out of the ownership, maintenance or use of a low-speed vehicle.

Section 3: Penalties:

1. Any Penalty for not following the rules of the road will be enforced with a citation and fee set forth by N.D. C. C. 39.

2. Any violation not covered under N. D. C. C. 39 is a citation and fee set at \$50 dollars.
