

# Jaguars whistled into foul trouble

The Grant County/Mott-Regent boys basketball team has been playing one whistle away from deep foul trouble, a trend that continued last week for the Jaguars.

The Jaguars hosted Garrison on the Elgin court Jan. 6, with the train heading for a victory – until it got derailed in the fourth quarter for a 49-65 loss.

With the game tied at 36-36 with 6:55 left to play, Garrison scored 31 points in the final quarter, including 14 free throws, to run away with the contest. Key players Mike Greff and Malachi Meyer were whistled out with five fouls, and two other players scraped to the end of the game with four fouls apiece.

The Jaguars finished the first quarter with a one-point deficit, then roared in the second quarter, outscoring the Troopers by 10 points, with William Grist and Greff combining for 16 of the quarter's 20 points for the Jaguars.

The Jaguars sailed some on-the-run assists to each other, displaying a gelling of the young team. Three in a row, including a long bomb from Greff to Grist, a lob from Rowan Prescott to Meyer and a bounce pass from Grist to Greff, led to the Troopers calling a timeout to regroup in the second quarter.

A halftime reset allowed the Troopers to start chipping away at the lead until the scoreboard crumbled in the final quarter as the Jaguars battled through a 31-point gallop by the Troopers.

On Jan. 9, the Jaguars faced Belfield on the Mott court in a high-

scoring 81-92 loss.

"It was a run-and-gun kind of game," Head Coach Pat Perkins said. "The boys played hard and well."

But fouls haunted the Jaguars again.

"We had too much foul trouble at the end and not a deep enough bench," Perkins said.

Meyer fouled out and three players stood with

four fouls at the final buzzer.

Grist poured in 27 points, with Greff adding 25 points in the showdown, with four Jaguars sinking treys. In the demonstration night on three-point shooting, Belfield netted nine three-pointers.

The Jaguars return to the home court in Elgin Jan. 17 against Center-Stanton.
