Water and Sewer: The meter for the Correctional Center has not been ordered yet.

Street and Lights: Nothing to report.

Buildings and Grounds: The scrubber upstairs is now working and it should be used to keep the gym floor clean. The ovens need to be scrubbed yet. Flowers will be planted by Breann again this year. Senior signs will be up and taken down before the All-School Reunion.

Equipment: Looking at purchasing a dump trailer. Clarence received two bids; one from Boespflug Trailers for \$11,500 and one from Badlands Trailers for \$11,650. This can be used for city cleanup to haul trees out, haul fridges and freezers and for hauling dirt. This will get used. Clarence recommends the trailer from Badlands Trailers for \$11,650. Motion by Breann, seconded by Mike to approve purchasing the trailer from Badlands Trailers for \$11,650 and other miscellaneous fees. Motion carried.
