

## City of Mott proceedings

### PROCEEDINGS OF THE MOTT CITY COUNCIL June 8, 2026 - Preliminary

The Council met for their monthly scheduled meeting on Monday, June 8, 2026. Present were Mayor Mosbrucker, Council members Steiner, J. Messmer, Wangsvick, K. Messmer, and Johnson. Treichel was absent. Also present were Superintendent Brian Steinke, Anthony Setness, Sarah Warner, Jody Olson, Kristen Olson, Joao Attenuati and Heather Watson. All motions are carried, unless otherwise stated.

K. Messmer moved and Steiner seconded the approval of the May 2026 City Council Minutes.

J. Messmer moved and Steiner seconded the approval of the police report as presented. There were 48 calls for service and three 911 calls. Investigations included suspicious person/vehicle/activity, criminal trespass, destruction/damage/vandalism of property/criminal mischief, juvenile, aggravated assault and a hit and run.

Heather Watson was here in response to the cleanup letter she received. She indicated that the vehicles were all properly registered and insured and didn't see why we were asking her to move them. As for the siding, the house is due to be jacked up and then the siding will go on. She said if the siding was not on by the end of

the year, she would dispose of it. The Council told her the cars were acceptable as long as they stayed registered and insured.

Jody, Kristen and Joao were here to express their frustration with the current state of Second Street. They are unable to drive on the road to access their homes and it's been either torn up or blocked off for construction for far too long. Anthony Setness took all the information under advisement and would be addressing the issues with Tand Construction.

Anthony presented the Moore Engineering report. Televising and cleaning of sewers concluded on Friday and Anthony received the videos just prior to the meeting. He will be review-

ing and producing a report of results and suggestions. Steiner moved and Johnson seconded the approval of Tand pay application #6 for \$629,909.70. Troy informed Anthony that the City wants the manhole pieces that were ordered as part of the bid process with Tand.

The Mayor and the Council member heard from some of the folks that were sent cleanup letters. A couple of extensions of timelines were requested and granted.

Wangsvick moved and J. Messmer seconded a purchase of a Toro push mower for the Armory. The City is paying and billing the Armory.

K. Messmer moved and Johnson seconded approving a

quote from Dakota Pump Control for \$21,755 to replace control valves, pipes, transducer assemblies, and electrical wiring in the water tower. This job may fall under current grants, so that will be explored prior to placing the order.

City Superintendent has been trying to get the City ready for the All-School Reunion and Mott the Spot this weekend. Also discussed replacement of pumps in the West Mott lift station. Those were purchased used some time ago. We are going to see if we can get rebuilt replacements. Waiting on a quote to replace the garage door to the cold storage building.
