Makoti City February meeting minutes

The Makoti City Council met on Monday, February 2, 2026, 7:00 PM at the Makoti Senior Center. Those in attendance were Mayor Karna, S. Huus, C. Huus, Howell, Giesen, Butterfield, Travis Robbins, Dar Huus, Connie and Joel Fischer, Joan Stafslien, Liz Huus, Mike and LeeAnn Larson, Vonda Rensch, Wayne and DelRay Giesen, and Howard Enochson. Mayor Karna called the meeting to order, along with minutes, financials, and bills for the month. A motion was made by Giesen, seconded by C. Huus, to accept the consent agenda including minutes from the previous meeting, monthly financial reports, and bills to be paid. RCV/MC. Expenses for the month are all employee salaries, Circle Sanitation \$1,137.00, NorDak North \$57.95, FDHU \$30.00, Ralph Butterfield \$435.66, BND Sewer Lift Loan \$412.50, BND Water Tower Loan \$1,200.00, Enerbase \$57.20, Pace Analytical National \$396.00, Darthy Huus \$258.58, and Travis Robbins \$83.11.

Several Community Groups were represented, including Legion and Auxiliary, Makoti Development, Park Board, and Threshers Association. The Legion proposed forming a committee to get a pavilion built in place of the old Legion Hall. The committee will oversee gathering design options and requesting funding from various organizations and grant opportunities. The committee was formed and a meeting scheduled for February 7, 2026. The other community groups that were present gave updates. Discussion was held.

Old business was discussed. The

Health Department was in contact with the city regarding a derelict property in town. The city is expected to follow through with having the property cleaned. Dar Huus finished the online auditor training and will be doing training with S. Huus this month. Dar Huus contacted Dakota Pump & Control about servicing the Lift Station. A motion was made by C. Huus, seconded by Howell, to use DPC to do an annual Lift Station inspection for 2026. RCV/MC. The council discussed the possibility of purchasing new snow equipment in the summer, depending on prices. The process for filling the council member vacancy was discussed and will be addressed at the next meeting.

New business was discussed. Brittany Giesen announced she is resigning from the City Council, pending finding a replacement. The city's CDs were renewed on January 21, 2026. S. Huus switched them over to a 5-month term to get the best rate available. They are now 3.15%. The Tax Equalization meeting is scheduled for Tuesday, April 7 at 5PM and will be held by conference call at City Hall. The monthly city meeting will directly follow that meeting. The council discussed the need for an increase to the monthly water fee. S. Huus and Dar Huus will research and review amounts needed and present options to the council at the next meeting. They will also research options for vacant lot water and sewer access fees. Discussion was held. Howell made a motion to adjourn the meeting, seconded by Giesen. -Stephanie Huus Auditor.

The Christmas party was a huge success and a great time was had by all.



The right is reserved to reject all bids, and to waive any informality in any bid, and to hold the bids for a period not to exceed thirty (30) days from the date of opening bids.


