

Goehring Announces Availability Of Orchard Grants

Agriculture Commissioner Doug Goehring has announced that grants are available to support the creation of permanent community orchards in underserved areas to increase community access to and consumer education of specialty crops.

"I encourage community development groups, economic councils, schools, nonprofits, 4-H and FFA chapters to apply," Goehring said. "Funds can be used to purchase plants, trees, planting supplies, soil amendments, irrigation and fencing supplies."

There is \$120,000 available for the grants and organizations can ask for \$40,000 or more. The grants are available on a competitive basis and will be scored on community impact, location priorities, community participation and support, education and outreach, funding priorities, long-term sustainability and budget. Applicants will need at least one letter of support from a community partner or organization.

Grant funds cannot be used to purchase land, permanent structures or for capital expenditures. Grant funds are for new projects and not the continuation of existing projects.

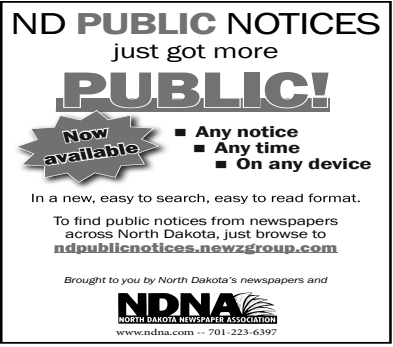

ND Food Expert: High Prices Are Motivator To Cut Waste

Food prices in the U.S. are forecast to rise by nearly three percent by the end of the year and a North Dakota professor specializing in nutrition said despite elevated grocery bills, there is still too much food waste.

Julie Garden-Robinson, food and nutrition specialist for North Dakota State University Extension, has tips on protecting your budget and the environment. April 30 was Stop Food Waste Day, and Garden-Robinson said it was a good reminder to maximize the value of your grocery haul. At home, people sometimes throw out food before they need to, noting lingering confusion about "use by" dates.

"That milk that might be in your refrigerator that has a 'best by' today or 'sell by' today, that doesn't necessarily mean that you can't drink that milk for a few days," Garden-Robinson pointed out.

Garden-Robinson noted safety is important but consumers should use common sense to determine if a product has a little extra shelf life. She recommended better meal planning and going through your cupboards before restocking.

Awareness day organizers say 45 percent of root crops, fruits and vegetables produced globally are lost or wasted each year, contributing to eight percent of total greenhouse gas emissions.

Researchers said it does not all fall on consumers, with a significant amount of waste occurring through supply chains. Garden-Robinson added certain industries like hospitality are getting the message by doing things like donating surplus food to hunger relief organizations.

She stressed consumers can do it too, or if your grocery budget is limited, think about preserving what you have.

"If you bought too much, you can freeze it," Garden-Robinson suggested. "If you have the skills, you can also safely can food. It's an important balancing act not to overbuy and to throw out that money that you worked hard to have."

On the environmental side, Garden-Robinson emphasized composting food waste in your backyard is another solution. When done properly, it can enrich the soil without using chemical pesticides, keep food waste out of landfills and help to reduce methane emissions.

State Park Visitors Urged To Help Protect Parks From Invasive Species

The North Dakota Parks and Recognition Department, in partnership with the North Dakota Game and Fish Department, is highlighting the importance of stopping the spread of Aquatic Nuisance Species (ANS) during the week of May 3-9. ANS Awareness Week in North Dakota is intended to further educate visitors on the potential risk to public health, property and the economy from the negative impacts associated with ANS to ultimately stop the introduction and spread of ANS in the state's waterways.

Nuisance, or invasive, species are aggressive species that pose serious threats to local ecosystems and water quality. Park visitors play a vital role in helping prevent the spread of invasive species across North Dakota through some quick and easy tasks:

- Clean gear: Before leaving a body of water, thoroughly clean all equipment such as boats, kayaks, fishing gear, and any other gear that comes into contact with water. Remove all plants, mud and debris.

- Drain water: Drain all water from boats, motors, bilges and live wells before leaving the area.

- Dry gear: Allow all gear to completely dry before using it in another body of water.

- Dispose of bait properly: Never release unused bait into the water.

- Stay informed: Learn about the ANS species in the park you're visiting and follow any guidelines or regulations provided by park staff.

With most state parks offering water access across North Dakota, visitors are reminded to help pro-

tect all waterways by practicing responsible watercraft use. To support these efforts, some state parks have tools to help reduce risks of spreading invasive species:

- Lake Metigoshe State Park features a convenient watercraft cleaning station, developed in partnership with the ND Game and Fish Department. This Clean, Drain, Dry and Dispose (CD3) station allows anglers and boaters to easily rinse off equipment.

- Grahams Island State Park boat ramps include an innovative Internet Landing Installed Device Sensor (ILIDS) to detect incoming watercraft and play a helpful reminder: remove all aquatic plants and animals before and after launching.

- Fort Stevenson State Park also has an ILIDS at its de Trobriand Marina and a CD3 cleaning station at the Garrison Marina.

This equipment is available 24 hours a day, seven days a week. Lake users should properly drain water from boats and gear that can lead to the accidental spread of ANS.

"Preventing the spread of invasive species starts with every water user making clean, drain and dry part of every outing," said Kathy Duttonhefner, Natural Resource Division Chief at NDRPD. "These simple steps play a critical role in protecting North Dakota's waters, forests and wildlife."
