CITY OF PALERMO MINUTES AUGUST 4, 2026

Those present were: Walter Dunham, Raquel Ragan, Kenny Meckle, Kevin Marmon, Wayne Enger, John Sauber, Cal O'Clair and Myron Huelle.

Mayor called the meeting to order.

Minutes from the last meeting were read. Motion to accept the minutes as read was made by Kenny Meckle, seconded by Wayne Enger. Motion carried.

Old Business:

John Sauber was at the meeting to talk about the paving project. The surveyors have been in town. He also said it would be better to put out our own bids for the paving instead of trying to tack on to a different project. Once they get the project half figured out, he would be back. The roads being paved are Norway, Helene, Williams, Diamond and Washington.

Revision of the Ordinances Second Reading. Kenny Meckle made this motion: I move that the Mayor, with the advice and consent of the City Council, confirm and ratify the appointment of Ryan Sandberg, City Attorney, under N.D.C.C Section 40-11-09, to prepare and submit the revision of the City's Ordinances, and that this confirmation ratify and relate back to the Council's prior action directing the City Attorney to prepare a new set of Ordinances. Raquel Ragan seconded with this motion: I move to adopt Ordinance No. 1, the enacting Ordinance adopting the Revised Ordinances of the City of Palermo of 2026, consisting of Chapters I through IX, as a single Ordinance and as a revision of the City's Ordinances under N.D.C.C. 40-11-09, to be maintained in book form on file with the City Auditor, and to take effect upon final passage and approval without publication, as provided in Section 6 of the enacting Ordinance and N.D.C.C. Section 40-11-07. Kenny Meckle - Yes, Wayne Enger - Yes, Kevin Marmon - Yes. Motion carried.

Motion to accept the preliminary budget was made by Kenny Meckle, seconded by Kevin Marmon. Motion carried. The final budget meeting will be on Tuesday, October 6, 2026, at 7:00 PM.

Motion to hire Dakota Foam to spray foam in the City Shop was made by Wayne Enger, seconded by Raquel Ragan. Motion carried.
