Girls shine at Region, grab title

Staff Report

Bowman County girls dominated the South West Regional track meet held at Beach May 12.

The Bulldogs scored 170 points to easily win the team title, while Beulah was second (128.5) and Killdeer came in third (106.5) in the field of eleven schools.

They were followed by Hettinger County (84), Dickinson Trinity (76), Richardton-Taylor (47), Glen Ullin/Hebron (43), Hettinger-Scranton (25), Grant County/Flasher (19), Beach (18) and Heart River (15).

Junior Quin Andrews led the scoring charge, picking up victories in the 100 meters (12.45) and the 200 meters (26.56 seconds), while also placing second in the 100 meter hurdles and fourth in the long jump.

In the high jump, eighth grader Avery Burke won by clearing 4 feet, 10 inches. She also was on the first place 4x400 meter relay team with Jaylee Fischer, Aspen Brewer and Hadyn Hlebechuk. Avery Burke also placed seventh in the 300 meter hurdles behind Aspen Brewer (sixth). Avery Burke was also seventh in the 100 meter hurdles.

Brewer won the 400 meters with a time of 1:01.83.

Jaylee Fischer won the 1,600 meters with a personal best of 5:25.01, finishing just ahead of Berg (5:26.55). Fischer was also fourth in the 800 meters, with Berg placing second (2:25.79).

In the 3200 meters, the Bulldogs had four runners taking fourth through sixth place (Honeyman, Sarsland, Berg and Abigail Burke). Bostyn Blankenbaker placed eleventh.

cate for producers, strengthen rural communities, and influence policy.

At its core, cooperation was not only an economic strategy. It was a civic one.

Farmers who helped build cooperatives often served on school boards, township boards, and held local leadership roles. They understood that strong communities required participation, shared responsibility, and long-term thinking.

This reflects a broader American principle first introduced in 1776 — that government derives its authority from the people. In North
