

Season nears its end

Eagle girls bound for postseason, boys wrap up after Belfield rivalry game

After a Feb. 3, 56-51 loss to Bowman County at home was followed by a 56-51 New Salem-Almont nailbiter in the same location, the South Heart Eagles dropped their third-consecutive game, 68-56 at Flasher in a non-district contest. Meanwhile, the girls played their final game on Tuesday, Feb. 10 at New England, but stood at 12-6 overall and 3-3 in District 7 at press-time.

Raiders 49, Eagles (girls) 48

For the second time in three games for South Heart, a single point proved to be the decider, only this time it was Richardton-Taylor who scored the crucial points. The Raiders were down by 10 points headed into the final frame, only to overcome that deficit on their way to a crucial District 7 victory.

Previously, the Eagles overcame Trenton by a 67-66 score on Jan. 24 and followed that up with a win over D7's Hettinger-Scranton at home, 57-33. But despite Kailee Tescher's team-high 12 points versus the Raiders – which included three shots from behind the arc – RTHS's Paige Christensen converted one of her two free throws with 11 seconds left to post the win as she scored a game-high 21 points.

Bulldogs 63, Eagles (boys) 45

South Heart's boys got their week started with a gritty District 7 contest at home versus Bowman County, and saw the visitors post a slight lead at the half, 32-29, as senior guard Brody Reindel rained in a pair of 3-pointers to keep the game close and junior sharpshooter Jaymison Wilke scored all 10 of his points in the opening 16 minutes of gametime.

Junior guard Garrett Bargmann drained a pair of treys on his way to a team-high 13, but Bowman County was able to pull away with a 31-point second half that saw the visitors limited to only 8 points in the final frame.



For BCHS, Jackson Fischer shot 8-of-11 from the free-throw line and had the game-high at 20, Cansas Duffield had another solid night at 14 points with a pair of 3-pointers and Jonah Njos scored 12, which included a trio of shots from behind the arc.

Holsteins 56, Eagles (boys) 51

In a game South Heart commanded until the :40 mark of the third quarter, New Salem-Almont was able to pull away in the closing minutes after being behind 26-20 at the half-time buzzer. Bargmann scored 13 of his team-high 19 points in the first half for the Eagles and Wilke was lights-out from distance with three treys and a double-digit 13 points.

But while junior center Shayden Moe and sophomore standout Peyton Erickson each scored 8, no other South Heart player passed the 10-point barrier on the night. The Holsteins responded with three athletes in double-figures, including Elias Smith's game-high 21 and 16 from Maksim Nelson.

Bulldogs 68, Eagles (boys) 56

District 8 Flasher came into the Friday-night matchup at 6-9, but sent South Heart home with their third-straight loss as the other Bulldogs went into the half with a slim, 28-23 advantage before pulling

away with 38 points in the final two quarters for the win.

Erickson showcased his skills with a team-high 24 – which included a trio of treys – and Wilke found the mark from range and scored 16, but no other South Heart player got past 4 points on the remainder of the scorecard. That wasn't enough to overcome Tiernan Fleck's game-high 33 and 15 more from Kelton Friesz.

South Heart's girls finished off their 2025-26 regular season on Tuesday, Feb. 10 at New England and the Class B, District 7 postseason awaits with the quarter-finals tipping off Feb. 14. The boys were in action on Feb. 9 against District 7 rivals Richardton-Taylor, but the results weren't in by press-time.

South Heart's boys will be back on the court in the huge District 7 rivalry matchup at Belfield on Friday, Feb. 13 after squaring off with Grant County/Mott-Regent the previous night, and the squad's densely packed closing schedule will see their regular season end on Feb. 19 at Beach.
