

Aneta Turkey BBQ, summer celebration this weekend

NCAC to hold 33rd Annual Art Show June 26-28

The highlight of the year for Aneta is just a short time away. The 65th Annual Turkey Barbecue and Summer Celebration is set for Thursday, June 18 through Sunday, June 21, and all kinds of fun for all ages and interests are planned.

Main Street is the scene of a car and bike show starting at 11 a.m., and a tractor pull also takes place at that time with cash prizes by the Stump Lake Tractor Club (weigh-in is at the old CHS elevator before 10 a.m.).

Activities start Thursday evening at 7 p.m. with a basketball game in the Aneta Auditorium. The Aneta Orchard will be the scene of rhubarb tasting and recipes starting at 2 p.m. There will be a rib supper at the Whitetail Bar beer garden served from 5:30 p.m. until gone, followed by a talent show at the Aneta Auditorium at 7 p.m. and karaoke at the beer garden starting at 9 p.m.

The Aneta Auditorium will have a lunch stand available between 11 a.m. and 2 p.m. There will be a vendor show at the city park and pavilion between 12 noon and 8 p.m.

Lineup for the main parade begins at 3:30 p.m. at Sacred Heart Catholic Church. Lineup and registration for the kiddie parade starts at the same time, but at the bank. Registration is required, and the kiddie parade is open to entrants 12 and younger.

Come to an all-faiths service in the city park Sunday at 10 a.m., then enjoy brunch in the Aneta Auditorium basement between 11 a.m. and 2 p.m.

Events kick into high gear Saturday with a pancake breakfast at Sundahl Lutheran Church from 7:30 until 10 a.m., then kid-oriented fun starts with kids' games (for 12 and under) at the Aneta Orchard at 10 a.m., and a children's museum at the fire hall from 10 a.m. until 4 p.m.

Saturday afternoon is filled with activities. Chainsaw carving and blacksmith demonstrations take place from 12 noon to 8 p.m. at the lot north of the pavilion. A dog talent show starts at 1 p.m. at the tennis court by the pavilion (registration info on the turkey barbecue's Facebook page), then attendees can witness talented dogs of a different kind. The Nelson County Sheriff's Office K-9 unit will have a demonstration right after the talent show.

There will be a \$50 gift card awarded for the best in each of these categories for the kiddie parade: Best in Show, Aneta Theme, Turkey Theme, and Patriotic. Inflatable games take place in the city park between 4 and
