involvement. The new park project began after the community's previous playground was removed due to safety concerns, leaving local children and families without a dedicated space for outdoor play. With a growing number of young families in the area and limited nearby recreational opportunities, creating a new safe and welcoming gathering place became an important community goal. Significant progress has already been completed at the new park site, which is centrally located in town and provides a safer location for families and children than the previous playground site along the highway. The basketball court, sidewalk, and pavilion surface are finished, and the playground equipment package has been ordered with half of the total cost already paid. Upcoming phases of the project include installation of the playground structure and safety surfacing, construction of a fence around the basketball court, and completion of the pavilion with assistance from a local builder. The total project cost is estimated at approximately \$132,000 for the new playground, basketball court with fencing, and pavilion. To date, \$52,000 has been secured through a combination of grants, local donations, and in-kind support. About \$38,000 remains on the playground equipment balance, with the remaining project costs tied to completion of the fencing and pavilion portions of the project. Local residents, contractors, and supporters have continued contributing time, labor, and resources throughout the process, helping maintain strong momentum as the

project moves into its next phase. Completion of the playground portion is anticipated within the next year once the remaining balance has been paid. Additional components, including the basketball court fence and pavilion completion, are planned as funding allows, with remaining work expected to continue into spring 2027 if necessary. As the project moves into its final stretch, community members, families, alumni, businesses, and supporters still have opportunities to help bring the park to completion. Donations may be made in memory of loved ones, in honor of children or grandchildren, or on behalf of families and businesses that would like to be part of a lasting investment in the community. Donors will also be recognized as part of the completed park project through a community recognition display honoring those who helped make the park possible.
