and other vaccine-preventable diseases. Infants ages 6-11 months who are traveling internationally or to outbreak areas within the United States are recommended to receive one early dose of MMR vaccine before travel. Early and accelerated vaccination continues to be recommended for Grand Forks County. The Ransom County outbreak was declared over on May 13.

Children who receive an early dose before 12 months of age will still need the routine two-dose

series after their first birthday. Individuals planning international travel are encouraged to talk with their healthcare provider to ensure they are adequately protected against measles before departure.

Adults born before 1957 are generally presumed immune due to a history of measles illness. Adults born in 1957 or later should ensure they have received at least one documented dose of MMR.

MMR vaccines are available

through most clinics. For families in need, the federally funded Vaccines for Children (VFC) Program provides vaccines at no cost through participating providers.

Individuals unsure of their vaccination status are encouraged to consult their healthcare provider. Immunization records can be reviewed at hhs.nd.gov/IRR or by contacting a provider.
