ROLETTE CITY PROCEEDINGS REGULAR MEETING MINUTES WEDNESDAY AUGUST 5, 2026 ROLETTE CITY HALL

Rolette City Mayor: Blaine Scott called the meeting to order on Wednesday the fifth day of August 2026, at the Rolette City Hall-7:00 P.M. The following members were present: Mayor: Blaine Scott, Councilmembers: Andy Gilje, Nathan Casavant, Randy Rost & Jaime Kegley, City Auditor: Kim Azure and Public works: Don Berg. Others in attendance: Rolette County Deputy: Keaton Lafromboise, Laducer Sanitation: Mitch Laducer and Raymond Auka.

The July regular meeting minutes were read. A motion was made by Gilje and second by Casavant to approve the minutes as read. Roll call vote-all agreed-Motion carried.

Review of Police log for Rolette City, a Motion was made by Kegley and second by Rost to approve the Police log for July 2026. Roll call vote-all agreed-Motion carried.

Laducers Sanitation will be increasing the monthly Garbage fee by 10%. \$800.00 will be added to the City monthly garbage fee due to the increase in fuel. Mitch attended the City council meeting to inform them of the new garbage surcharge fee. By the September meeting, Laducer will supply a list of all the residential and commercial accounts that are currently receiving garbage pick-up services in Rolette. The new garbage fee for the City of Rolette will be \$8,800.00 per month.

A Motion was made by Casavant and second by Gilje to approve the City purchase of a 2026 DOO

DL220-7 payload for \$190,000.00 per the street department, the Cities 2006 John deere payload was utilized as a trade in and credited in the amount of \$65,000.00.

The invoiced approved amount of \$125,000.00 will come out of the City Sales tax fund. Roll call vote-all agreed-motion carried.

A Motion was made by Gilje and second by Kegley to approve the application for a local permit for the Rolette Comet Booster club, to hold bingo, raffle and a calendar raffle. Roll call vote-all agreed-motion carried.

The Maguire iron water tower cleaning and inspection was approved by Rost and second by Gilje, this contract will end in 2030. The fee for the inspection and cleaning is \$1,750.00. Roll call vote -all agreed-motion carried.

Motion by Gilje and second by Kegley to approve the Demolition permit for Diane Arstein, this is for a vacant home on 504 State street of lot 11, block 20 Ots. Roll call vote-all agreed-Motion carried.

A Motion was made by Casavant and second by Rost to approve the Legacy cooperative propane leasing agreement for 404 Park Street @ \$100.00 and 702 State Street @ \$75.00. Roll call vote-all agreed-motion carried.

A Motion was made by Kegley and second by Rost to approve the Rolette park district preliminary budget FY 2027 for the amount of \$33,000. Roll call vote-all agreed-Motion carried.

A Motion was made by Gilje and second by Kegley to approve the City of Rolette preliminary budget FY 2027, for the amount of \$139,000. Roll call vote-all agreed-Motion carried.
