Hettinger Restaurant Owner Arraigned

Appearing in the Adams County Courtroom on Dec. 1, Carla Tranmer was arraigned at a preliminary hearing for the charge of Endangerment of a Child- a Class C Felony, Possession of Drug Paraphernalia- a Class A Misdemeanor, and three counts of Possession of a Controlled Substance- a Class A Misdemeanor.

Southwest District Judge Rhonda Ehlis ruled that the prosecution had met the low burden of probable cause necessary to proceed with a trial. The defense filed a plea of 'Not Guilty' on all counts.

Adams County Chief Deputy Jeff Gooss testified at the hearing advising the court that his investigation into illicit activity in and around Carla's Corner Café began several months back in February. Gooss continued to testify that he made several observations indicative of illegal activity at the place of business in addition to conducting traffic stops and drug interdiction techniques of patrons and employees of Carla's that lead to drug-related arrests.

According to Gooss, Joel Bonomo, Carla's significant other, was placed under arrest for drug charges in September. At that time, Bonomo admitted that meth had been "coming and going" out of the business, and that he had conducted multiple drug transactions out of the back of Carla's Corner Café.

Following Bonomo's arrest, the Sheriff's Office acquired a warrant to search Tranmer's residence,



Carla's Corner Café, and Carmel's Cleaner's- another local business.

During his testimony, Gooss advised the court that a 5ml oxycodone pill was in Tranmer's office at the restaurant. In the residence, multiple glass smoking devices were discovered in addition to small baggies with a white powder residue- all of which field tested positive for methamphetamine.

A container labeled 'Peyote' was also seized.

Officers also discovered, in the residence, a room in the basement that appeared to accommodate Tranmer's 6-year-old granddaughter. Prescription medication, not belonging to Tranmer's granddaughter, was found in the child's room.

"Nothing that was found was outside the reach of the 6-year-old," testified Gooss.

The minor child was also present at the time the search warrant was executed on Sept. 8.

A date for trial has yet to be determined.

2023 NORTH DAKOTA SOYBEAN COUNCIL (NDSC) **ELECTION** NOMINEES SOUGHT FOR ADAMS COUNTY REPRESENTATIVE

On or about Dec. 7, 2022, the NDSC mailed a nomination form to soybean producers of record in the above-named county. To be considered, nomination forms must be filed with the County Extension Agent for the above-named county. The County Extension Agent must receive the completed nomination form by Dec. 23, 2022, or your mailed-in form must be postmarked no later than Dec.

23, 2022. If you do not receive a nomination form in the mail, contact your County Extension Agent or the NDSC to obtain one. Look for the green envelope in the mail.

After nominations are validated by the County Extension Agent, names of the nominees will be sent to the NDSC to be placed on the 2023 ballot. On or about Feb. 8, 2023, the NDSC will mail to soybean producers of record an election ballot with instructions. Look for the blue envelope in the mail. Completed ballots must be post-marked by March 1, 2023. The newly elected County Representative will be notified by March 13, 2023. In late March, those County Representatives will elect one County Representative to serve on the NDSC board of directors
