Congress must protect this affordable internet program



As another election year begins, we can expect to hear plenty of political bickering, negative campaigning, and heated

disagreement. But before we rush headlong into that maelstrom, Congress has an opportunity to come together and save a program that promotes economic growth, workforce development, and innovation. I'm talking about the Affordable Connectivity

Program (ACP). The ACP, authorized in the Bipartisan Infrastructure Law, is simple: it provides eligible citizens \$30 per month for internet service. As we learned during the pandemic, internet access is a necessity, not a luxury. From virtual classroom activities to job searching to interacting with government agencies, the internet is as much a part of our lives as electricity. And ACP helps keep 21.5 million households across the U.S.connected, including over 16,000 here in North

But there's a problem, ACP funding is set to run out in April. If Congress allows this to happen, millions of Americans who can least afford it will lose their lifeline to the internet.

And there's a potential solution. A bipartisan coalition of Representatives and Senators recently introduced the Affordable Connectivity Program Extension Act (H.R. 6929/S. 3565) to provide \$7 billion of necessary funding. We are thankful to Senator Cramer for being an original cosponsor and a vocal proponent for keeping the program alive. We have asked Senator Hoeven and Congressman Armstrong to join him in ensuring North Dakotans don't lose affordable access to the internet.

Voting to protect the ACP should be a no-brainer for every member of Congress for three very simple reasons. The program is popular, has bipartisan support, and it works.

According to a recent poll, Americans across the board overwhelmingly support the ACP. Support spans rural (68%), suburban (78%), and urban (81%) areas, as well as strong majorities across all generations, with support peaking among seniors (83%). In fact, there is not a single subset of voters (age, income, race, political lean, gender, region) where support falls below 60%.

And the same poll shows bipartisan support as well, including 64% of Republicans,

70% of independents, and 95% of Democrats. In a nation where disagreement seems to be everywhere, Congress has found at least one program where Trump voters, Biden voters, and everyone in between supports.

The broad support is less surprising when ACP's benefits are

First off, the ACP flows to rural broadband providers and private companies rather than the government itself. This publicprivate partnership allows many providers to participate, creates competition, and maximizes consumer choice in the marketplace.

And households are making the most of the benefits. According to Brookings, ACP has already created more than \$2,200 in economic benefit for low-income households enrolled in the program. ACP creates opportunities for entrepreneurs and small businesses in underserved areas, and helps small businesses around the nation connect with customers in their community and beyond. Further. students have access to online learning platforms, educational resources, and remote educational programs, leveling the playing field and promoting education for all Americans who want to learn.

Finally, the benefits are going to those who really need it. For example, U.S. veterans often fall on the wrong side of the digital divide, with as many as 15 percent of veteran households lacking internet access as recently as 2019. But the ACP is helping change the narrative. According to the USAC, more than 800,000 of the 2.5 million eligible veterans have signed up for ACP.

Beyond the immediate impacts, the ACP amplifies the impact of our investments in high-speed internet. In North Dakota, we are investing more than \$301 million of federal resources into improving broadband infrastructure, providing devices to those who lack them, and promoting the adoption of technology among our least connected and rural communities. We were one of the first states to benefit from Federal investments in the implementation of broadband through our rural broadband providers over the last two decades and now nearly every other state is



as well. But those investments cannot live up to its full potential if ACP funding dries up and thou-

sands of North Dakota house-

holds lose access to the internet. In an increasingly interconnected world. Congress has the opportunity to ensure residents stay connected. Technology is moving fast, and American cannot afford to fall behind other countries. Our economy, and the well-being of our citizens, depends on it.

The ACP is a critical component of our nation's continued economic growth, workforce development, and spirit of innovation. Allowing the ACP to end would be a great disservice to families who rely on the program to access vital online services and resources.

Congress should join together and show America that smart, practical programs can still garner overwhelming bipartisan support. It is time to fully fund the ACP, and it should be one of the easiest votes of the year for Senator Hoeven and Congressman Armstrong.

Musical History: There are several people who remember the organizing of the Guelph School Band in 1956-57 by Ray Holland (director/teacher) with 27 members from grades 7-12. They looked pretty sharp with their (new to them) uniforms for the spring concert. So along with that came the

support of the community in the form of Guelph Band Mothers. It's interesting to note that these first members passed along their spirit of community involvement to their progeny: Mrs. Esther Beck, Mrs. Mildred Brown, Mrs. Delphine Bensen, Mrs. Bernita German, Mrs. Shirley German, Mrs. Mable Hansen, Mrs. Marie Maddock, Mrs. Madeline Maddock, Mrs. Esther Warner, Mrs. Pearl Thorpe, Mrs. Virginia Scheffert, Mrs. Genevieve Vie. Mrs. Ethel Sund, and Mrs. Marge Visto. These mothers sponsored innumerable functions, always

involving food, to raise monies to buy uniforms and instruments which were then rented to students for a fee of \$5 monthly. The band performed in parades, concerts, social gatherings, contests from local to state, basketball games, etc.

When the school closed in 1970, the band members at that time went on to join the Oakes School Band. Otherwise, the Guelph Band no longer existed. That is, until 1982 when the community decided to gather former band members and started practicing to perform at the 1983 Guelph Centennial under the direction of Mrs. Vivian Weseloh. This band performed at many parades around the area, as well as the Riverside Supper Club, funerals and always the Guelph-Ludden Turkey BBQ held every summer on the third Sunday of July, now under the direction of Susan German. You know I'm old when I tell you I'm the only original member of the Guelph School Band still playing.
