The measure to eliminate property tax is being circulated, and signatures collected to place it on the November ballot. There is also a strong, concerted effort to once again scare voters to go against their own best interest.

The measure is simple and does two things: it provides huge RELIEF by using excessive state revenue to replace what we are currently paying in property taxes. We get to keep that amount every year! And it creates true REFORM by stopping taxation based on valuation increases, ending confusing mil levies, and no longer being forced out of your own home.

How do dogs know a storm is approaching?

FARGO — What is it that dogs are picking up on when they get nervous before the people in the house are aware a storm is coming? A quick search on the web offers a pack of websites offering answers

with great certainty but nothing in the way of support. Air pressure changes more in the vertical than horizontal. Riding up an elevator ten floors is a greater pressure change than from any approaching storm, so that's likely out unless you know a dog that freaks out on an elevator ride.

A dog's sense of smell is many times more acute than that of humans, but there is no evidence that storm smells are carried far out ahead of an approaching storm. The sound of distant thunder is more plausible because sound waves can travel out ahead of a storm and humans are not that good at hearing low-frequency sound at low volume. The fact is, we don't know why some dogs seem sensative to approaching storms.
