steps over the past 1.5 years to address incidents at high school extracurricular events in North Dakota The issue of racial harassment of high school athletes was thrust into the public eye when two Native American players on the Bismarck High School boys basketball team endured taunts during a Jan. 31, 2023, game in Jamestown, the Bismarck Tribune reported.

Those incidents led larger schools to ask

for the policy, because there was no clear and consistent policy, Bentz said.

"I don't see it here," Bentz said of racial harassment at games. "I do hear about it, though, things that happen at other schools. It's out there. We've been fortunate and part of it is that kids and parents just know it's not going to be tolerated."

'Our community supports our studentathletes in a positive manner. ... They wanted to put something into place, because they noticed in these larger schools incidences on the rise and they needed to do something,' Nieuwsma said.

Students should be aware the policy could impact their own ability to compete. Bentz said. For example, if a football player is ejected from a volleyball game Thursday night, he will not be able to play Friday night.

'Getting back to the heart of what these competitions are about, I view them as an extension of the classroom in a way that students can learn lifelong lessons. There's a winner and a loser, and you're going to do that with class and don't blame officials or anything that's outside your control," Nieuwsma said.

Other expectations

The NDHSAA board of directors approved behavior expectations several years ago for regular and postseason competitions, but this policy extends disciplinary measures. Other expectations in place include:

•Respect the American flag and the national anthem.

Contesting schools shall each have an authorized faculty representative present who shall be responsible for his/her school's participants, students and fans throughout the contest.

 Spectators must wear appropriate clothing. Those who do not comply or who wear clothing that is vulgar, obscene or is in some other way inappropriate, as determined by school/ tournament personnel, will be removed from the facility if they do not cooperate with this behavior expectation.

•The use or appropriate language

is expected at all times. Profanity, negative chants, trash talk, name-calling, personal attacks or other acts of disrespect are unacceptable and must be immediately addressed by school/tournament administrators. Any discriminatory slur will result in immediate removal from the facility.

 Any attendee ejected from a NDHSAA tournament venue will be banned from the venue(s) for the remainder of the event.

•Respect the game/contest. Under no condition shall anyone other than the members of the official squad enter the playing surface. No one may interfere with the contest in any way.

·Handheld signs and flags, which do not obstruct the view of others, are permitted provided they are in good taste. Signs or other similar items contest/tournament officials deem to be in poor taste will be removed. Message or "white" boards are prohibited. The carrying of flags around the playing surface is NOT allowed.

 Artificial noisemakers of any kind are not allowed at any indoor events, including outdoor sports played at indoor venues.

Laser lights or any other lights deemed distracting to participants are strictly prohibited.

The use of unmanned aerial vehicles, also known as drones, is prohibited at all contests.
