Ruso man dies in rural McLean County crash

Crash remains under investigation

A Ruso man has died following a roll-over crash in rural McLean County earlier this week.

According to a press release issued Nov. 9 by North Dakota Highway Patrol Lt. Jenna Clawson-Huibregtse, a 63-year-old male of Ruso was involved in a fatal crash sometime between Nov. 8 and Nov. 9.

Clawson-Huibregtse stated the crash occurred between the evening hours of Nov. 8 and morning hours after the Ruso man lost control of his 1999 Ford F-250 that was traveling westbound on N.D. Highway 53.

"The driver lost control on the icecovered roadway and entered the south ditch where the vehicle rolled and came to a rest on the driver's side," Clawson-Huibregtse stated in the press release. "The driver was found deceased at the scene."

Assisting NDHP at the scene was the McLean County Sheriff's Office, Velva Ambulance and Butte Fire Protection District.

"The crash remains under investigation by the North Dakota Highway Patrol." she stated.
