His first call, in October of 1995 was to the church in the town of Taylor, WI. He served one church for 6 ½ years. While there, the county Social Service office called Pastor Carl to revitalize the Meals on Wheels program for the Taylor area. He got it up and running again.

Pastor Carl's second call was to a 6-point parish. Westhope, Newburg, Maxbass, Souris, Roth and Westhope Home of the Aged. All these towns are in northern North Dakota. Pastor Carl was the second Pastor. He served two churches every Sunday. He would rotate with the lead Pastor and with the SAM Authorized (Synod Minister). He was there for five and a half years. While there he was a driver for the Westhope Ambulance. While driving for the ambulance, in an

area that was heavily populated with deer, Pastor Carl suggested that a deer guard be put on the front of the ambulance. Shortly after another driver put the deer guard to the test and the ambulance came out of the test in A1 shape. Not so sure about the deer!

His third call was to Kulm and Edgeley, Pastor Carl held two services every Sunday. Pastor Carl was also a driver for the Kulm Ambulance. served those churches for three years.

He was then called to the LaMoure area. High Prairie (rural LaMoure) and Zion (Grand Rapids). For six months he was the interim Pastor for those two churches. Then High Prairie and Zion joined together with St. Johns of Verona and Good Shepherd of Englevale and became Heart of the Prairie Parish. At that time, Pastor

Carl became half time associate Pastor, with Pastor Cheri Danielsen.

After High Prairie closed, Pastor Carl became a supply Pastor for Heart of the Prairie Parish.

Pastor Carl has been a very active volunteer for the LaMoure Food Pantry for 10 years. All of the other volunteers enjoy working with him.

James 2:14 reads... Believe God and do good things 14 My Christian brothers, you say that you believe in God. Then you must show this in the things that you do. If not, your faith will not help you. It will not save you.

Pastor Carl believes, and it is shown by all the good works that he has done and continues to do.
