Horses and gophers in 1900 It appears there wasn't a lot happening in Dickey County in early January of 1900. Reports from the old newspapers don't have

any major crimes or disasters to report. Many of the fraternal lodges were electing officers and reorganizing for the new year.

For example, the Knights of Pythias lodge in Ellendale held a big event in the first week of January for its members with many of the Knights from Monango coming down to help install the new officers.

And new year feasts were common with an oyster supper at Merricourt considered a success with \$16 in proceeds for some unnamed charity or cause.

Not every event went smoothly, with a planned "surprise" party in Whitestone Township hampered by the fact the intended host was not home "so the surprise was on them," according to the Jan. 2, 1900 edition of the Dickey County Leader.

There were some near tragedies, including a runaway team of horses at Ludden. There was no one in the sled or wagon when the horses decided to take a quick trip through the countryside on their own.

A local Ludden resident mounted his own horse and chased the team three miles before bringing them to a stop in "the approved cowboy style," according to the Leader.

The newspapers even grew a little philosophical as they rang in the year 1900 by

noting, "The horseless carriage has come, the wireless telegraphy is being threatened but we have very good reasons for believing the armless courtship will never become very popular."

There was also a runaway in Fullerton. This time, the owner of the wagon and team was still on board when the animals took off running. The driver managed to get the team under control without injury, although his hat wasn't found for two days.


And the Dickey County Treasurer announced that they would pay the first batch of "gopher warrants" issued the summer before in the county.

There was a bounty on gophers back 125 years ago in an effort to control the rodent population. If the county didn't have enough cash on hand, it issued warrants that could be cashed in at a later date when the county's bank balance was a little stronger.


