**Facility Description** 

The reapplication is for a surface coal mining operation near Center, ND. Discharges consist of groundwater and/or surface runoff, and wash water from the washdown facility. Discharges are to Hagel Creek, Square Butte Creek, or Nelson Lake. Hagel Creek is an unclassified stream. Square Butte Creek, below Nelson Lake, is a Class IA stream; elsewhere, it is unclassified. Nelson Lake is a Class 3 lake.

Discharges covered by this permit are subject to surface water management conditions and designated locations described in surface mining permits approved following public review. Discharge structures are located within the boundaries of BNI Coal's approved surface mining permits which encompass all or part of the following: T142N,

R84W; T141N, R84W; T142N, R83W; and T141N, R83W.

**Tentative Determinations** 

Proposed effluent limitations and other permit conditions have been made by the Department. They assure that State Water Quality Standards and applicable provisions of the FWPCAA will be protected. Information Requests and Public Comments.

November 10th, 2025

Meeting called to order by Mayor John Lee at 6:00 p.m.

Council members present: Lisa Gusewelle, Eric Casson, Jennifer Gooss City Attorney and RaShell Simenson City Auditor. Gusewelle moved the motion to approve

the agenda, seconded by Casson; all voting aye, motion carried

Casson moved to approve previous meeting minutes seconded by Gusewelle; all voting aye, motion carried.

Treasurer Report
Gusewelle moved to approve the claims on hand, seconded by Casson; all voting aye, motion carried.

Gusewelle moved the motion approve the transfer of \$150,000 from the City Savings account the City Checking account to cover October expenses, seconded by Casson; all voting aye, motion carried.

Personal Appearance

Resident Michael Johnson appeared before the Council to discuss damage to his property that occurred when the City repaired the drainage ditch located on his land. He explained that the work left ruts in the soil and damaged areas of grass. Reuther provided pictures of the repair and stated he had reseeded the area. Council discussed to wait till spring to see how nature will take its course and address the situation at that time.

Mike Tietz, County Water Commissioner, appeared before the council to discuss that there had been complaints of outside companies pulling an over amount of water from the Square Butte Creek, which is causing water shortages to our local farmers. He asked the council to look into the idea of selling water to these companies, and he provided a document showing how profitable it is for other city's that do sell water. Mike explained that the Southwest Water infrastructure feeds Center from a north line and a west line which is more than capable

to handle for the city to sell water. Council agreed to look into this for the future.

CB Accounting Report-Tray Brownlee, via phone, updated the council after having technical issues with the city's accounting software Black Mountain and gaining access to the bank account he will begin to reconcile the accounts from September to current and provide a cash flow statement for revenue and expenditures.

Moore Engineering report: - Gusewelle moved the motion to approve Engineering invoice No. SIN005623 in the amount of \$12,000, seconded by Casson, all voting aye, motion carried.

Sheriff's Department Report- Gusewelle reported speeding tickets have been on the rise, mainly on HWY 25 east side of town. Publics Works Maintenance Report- Reuther reported CC Steel relined the sewer lines under Lincoln Ave Thursday November 6th. He provided a bid from Sletten excavating in the amount of \$2,650 to fix the damaged four curb stops. Due to confusion of the bid Council decided to table to obtain more information.

Reuther updated the council that Northern Plains Plumbing, Heating, and Air is continuing work on installing the new propane boilers and is expected to complete the project by the end of this week. In the meantime, the Civic Center is being heated using the two backup propane furnaces. Reuther also requested that Auditor Simenson publish the city's snow-removal ordinance in the newspaper and bring Burt Isaak into the city to assist with snow-removal efforts. Pool Manager Report- Kraft provided updates on pool maintenance, scheduled open hours, and reported that Empower Electric is still awaiting delivery of the phase protector.

Custodian- Plesuk informed the council that she had submitted her resignation two weeks prior and requested permission to withdraw it and retain her position with the city. Gusewelle moved the motion to keep Kayla Plesuk on the City Payroll, seconded by Casson, all voting aye, motion carried. Old Business

Casson moved the motion to seek out the Energy Efficiency Community Block Grant for LED lighting in the City of Center, seconded by Gusewelle, all voting aye, motion carried. Portfolios

Gusewelle updated the council the Golf course is closed for the season and expressed her appreciation to Brent Isaak. She also updated she is currently looking at a company to replace the doors going into the gym and a company to put in a fire suppression hood over the stove of the Civic Center kitchen.

Gusewelle asked if she could be part of Christmas gifts for employees and have a

\$300 budget.

Mayor Lee announced that employee negotiations will be scheduled in the near future. He also informed the council that the potential locations for the Lewis and Clark statues have been narrowed down to two sites.

Auditor Simenson announced that a new dog grooming business will be opening in December. # WINTER REMINDER SNOW REMOVAL ORDINANCE:

Snow Removal Ordinance: 3.0207 Removal of Snow and Ice from Sidewalk

It shall be, and hereby is declared to be, the duty of the owner or occupant of each lot in the City to remove from the sidewalk in front of or along the same, any ice or snow which forms, accumulates or obstructs such sidewalk, within twenty-four (24) hours after the ice forms or the snow ceases to fall thereon. Where the ice accumulated is of such character as to make the removal thereof practically impossible, the sprinkling of ashes or sand thereon within the time specified for removal in such manner as to make such sidewalk safe for the travel of pedestrians thereon shall be deemed compliance with the provisions of this article. No owner or occupant shall blow or shovel snow into public

Any person violating the provisions of this section shall be guilty of an infraction and upon conviction

streets except with permission of

thereof, shall be fined not more than \$500.00.

3.0212 Notice - Snow Removal o Street Cleaning

Whenever it becomes necessary to remove snow or ice or to sweep and clean streets, or to mark streets for traffic purposes there shall be designated by the city engineer or street commissioner the area and streets to be cleared of snow or ice or cleaned as aforesaid and the time during which such snow or ice removal and street cleaning and marking of streets shall be done and posting of such information in the area affected.

9.1409 Stopping - Parking - Over 48 Hours

It shall be unlawful for anyone to park or leave standing on any public street or highway in the City any vehicle for a period longer than forty-eight (48) hours consecutively, provided this section shall not include any area where a shorter time is provided for parking.
