Senators Introduce Legislation To Empower Farmers And Strengthen Rural Economies

Senator John Hoeven (R-ND) recently joined Senator Mike Rounds (R-SD) in introducing two pieces of agriculture legislation to expand markets for meat and poultry products and prevent against federal government overreach. The bills include:

- The New Markets for State Inspected Meat and Poultry Act, legislation to allow meat and poultry products inspected by state Meat and Poultry Inspection (MPI) programs to be sold across state lines. Currently, meat and poultry products inspected by state programs are limited to markets within the state, even though inspection at a state facility meets or exceeds federal inspection standards. This legislation is cosponsored by Majority Leader John Thune (R-SD) and Senators Angus King (I-ME), John Barrasso (R-WY), Kevin Cramer (R-ND), Steve Daines (R-MT), Chuck Grassley (R-IA), Cynthia Lummis (R-WY), and Tina Smith (D-MN).
- The Natural Resources Conservation Service (NRCS) Wetland Compliance and Appeals Reform Act, legislation to reform the NRCS within the United States Department of Agriculture (USDA). The NRCS Wetland Compliance and Appeals Reform Act would safeguard farmers, ranchers and landowners from bureaucratic overreach by the NRCS and empower producers to continue to protect their land as they see fit. This bill is also cosponsored by Senator Kevin Cramer (R-ND).

"Strengthening rural America starts with empowering the people who feed it," said Hoeven. "These commonsense reforms support our farmers and ranchers, open up new markets, and cut unnecessary red tape, boosting local economies, creating opportunity and delivering real benefits for North Dakota and the entire country."

The Stanley City Landfill will be open for the spring/summer season starting Wednesday, April 16, 2025, weather permitting. A landfill permit is now required to access the Stanley Landfill. The landfill permit can be picked up at City Hall at 221 S. Main Street during regular business hours, which are Monday through Friday, 8 a.m. to 5 p.m.

Landfill hours will be:
Wednesdays: 6:00 p.m. to 8:00 p.m.
Saturdays: 10:00 a.m. to 12:00 noon

Accepted materials: Clean wood only, trees, brush; Clean leaves and grass clippings for the Composite; Clean metals; Hide-A-beds must be separated from the frame. **All items must be separated.**
Stanley City Personnel will be inspecting all loads.

Secretary Of State Warns Of Misleading Annual Report Letters From Third Parties

North Dakota Secretary of State Michael Howe warns businesses and nonprofits to be aware of misleading letters offering to file annual reports on their behalf. The senders may appear to be working with the North Dakota Office of the Secretary of State, and the letters may look like a bill, ask for hefty fees, and/or express a sense of urgency.

"Our office prides itself on the customer service we provide to North Dakota business owners, big and small, as well as our nonprofits," said Secretary Howe. "It's unfortunate that out-of-state third-party entities are seeking to manipulate our North Dakota businesses and nonprofits into thinking they need to pay additional fees to remain in good standing with the State. Filing with the Office of the Secretary of State is quick and easy to do online, and we are always more than happy to assist and encourage folks to reach out to us if they need help."

Businesses and nonprofits are required to file annual reports to keep their registration in good standing. Annual reports are a simple filing that organizations can complete themselves through the North Dakota Secretary of State's online First-Stop Portal. The report requires updating business activities, mailing address, stakeholders or officers and directors, and for certain filings, information on membership interests, and land ownership or use.

Most annual reports submitted directly to the North Dakota Secretary of State are filed as soon as they are received. The third-party solicitation letters indicate that it takes considerably longer for them to submit the filing, and the organization must allow multiple weeks for them to file the annual report.

The annual report deadlines vary throughout the year depending on the business or nonprofit structure, and the filing fee is \$10 for nonprofits, \$20 for cooperatives, \$25 for corporations, \$25 for partnerships that have an annual report filing requirement, and \$50 for limited liability companies (LLCs). Third parties offering to do filings are charging fees in excess of \$90 to file.
